

MINUTES FOR EVALUATION OF TECHNICAL BIDS HELD ON 16th July, 2024 AT 2:00 P.M.

Name of Work : "Performance Based Maintenance Contract (PBMC) from km 177.00 to km 208.000 of Dawki-Amlarem-Jowai Road on NH-40E (New NH-206) (Length: 31 km)" during the year 2023-24 under Jowai Central Division in the State of Meghalaya. (Job No PBMC/40E/MG/2023-24/173)

(A) Reference of according sanction to the project:

i) Authority :- MoRTH, New Delhi

ii) Sanctioned letter: No.RW/GHT/MG/PBMC/2023-24/1(C No. 231301 Dated 27.12.2023

iii) Sanctioned amount of Estimate :- Rs.30.58 Crs.

(B) Bidding process :-

i) Bid Value :- **Rs. 23,58,85,894.00 (Exclusive of 18% GST & Inclusive of 1% Labour Cess).**

Consequently upon receipt of approval of PBMC RFP from the Regional Officer, Guwahati dated 06.05.2024, IFB/RFP for the work was issued by the Chief Engineer (NH) P.W.D (Roads), Meghalaya, Shillong. The IFB and the Bidding documents were made available in the CPPP, MoRTH of <https://eprocure.gov.in/eprocure/app> from 15th March, 2024 to 08th April, 2024 (upto 15.00 Hrs. IST).

However, due to certain significant modification in the RFP documents necessitating the cancellation of the current bidding process. Therefore, the tender was cancelled.

After necessary modification of the RFP it was reinvited Vide PW/CE/NH/24/2023/13 Dated 07.05.2024 and **Tender ID : 2024_MoRTH_806538_1** the IFB and RFP were made available in the CPPP, MoRTH <https://eprocure.gov.in/eprocure/app> from 08th May, 2024 to 06th June, 2024 (upto 15.00 Hrs. IST).

ii) Pre-Bid Meeting

The Pre-Bid Meeting was held on 16.05.2024 at 14:00 Hrs. as per schedule not a single bidder was present in the pre-bid meeting.

iii) Date stipulated for receiving the bid document.

The deadline for submission of online bid was upto 15.00 Hrs. IST on 06th June, 2024.

C) Technical Bid opening.

The online technical bid was opened on 07th June, 2024 at 15:00 Hrs in the Office chamber of Chief Engineer (NH) P.W.D (Roads) in presence of Bid Evaluation committee members & representatives of bidders. Total 2(Two) nos bids from the following bidders were received through online mode in the portal of <https://eprocure.gov.in/eprocure/app>, namely :-

(i) Dhar Construction Company.

(ii) Nibatskhem Marang.

D) The qualification information submitted online by the bidders have been examined on the basis of technical qualification criteria laid down in the bidding documents and compiled in the form of a comparative statement – "TABLE FOR EVALUATION OF SUBSTANTIVE RESPONSIVENESS OF TECHNICAL BIDS" to be placed before the Bid Evaluation Committee.

The Technical Bid Evaluation Committee (BEC) was held on 16th July, 2024 at 2.00 P.M. in the Office chamber of Chief Engineer (NH) P.W.D (Roads), in presence of the Chief Engineer (NH) P.W.D (Roads), as Chairman of Bid Evaluation Committee (BEC).

The Technical Bid Evaluation Committee (BEC) verified the documents and examined the technical bids & all other relevant papers. The deliberation of the Bid Evaluation Committee is as follows:

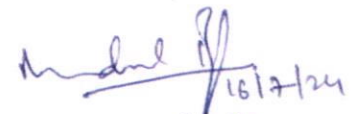
- i) The bidder, Dhar Construction Company has failed to submit the Mobile Maintenance Unit. Consequently, the bidder is liable to be non-responsive in accordance with Clause 4.1 (j) (1) & the C.V. of key personnel was not submitted in accordance with the Cl.4.1 j (2) of ITB (Annexure -I of Qualification Information)
- iii) The bidder, Shri. Nibatskhem Marang has failed to submit the Mobile Maintenance Unit. Consequently, the bidder is liable to be non-responsive in accordance with Clause 4.1 (j) (1).
- iv) The bidder, Shri. Nibatskhem Marang has not reach the Threshold Technical Capacity as per Clause 4.3(i).

In view of the above, as none of the bidder is responsive, the BEC has decided to cancel the existing tendering process and recommended that fresh bid is to be invited immediately and the time for publishing of the bids shall be for 21 (twenty-one) days.

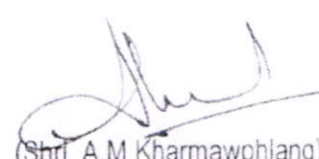

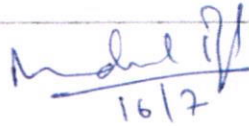
