

MINUTES FOR EVALUATION OF TECHNICAL BIDS HELD ON 12th August, 2024 AT 3:00 P.M..

(B) Bidding process :-

i) Bid Value :- Rs.51,16,27,319.00(Exclusive of 18% GST & Inclusive of 1% Labour Cess).

Consequently upon receipt of approval of PBMC RFP from the Regional Officer, Guwahati dated 06.05.2024, IFB/RFP for the work was issued by the Chief Engineer NH P.W.D (Roads), Meghalaya, Shillong. The IFB and the Bidding documents were made available in the CPPP, MoRTH of <https://eprocure.gov.in/eprocure/app> from 13th May, 2024 to 10th June, 2024 (upto 15.00 Hrs. IST).

However, due to certain significant modification in the RFP documents necessitating the cancellation of the current bidding process. Therefore, the tender was cancelled.

ii) Pre-Bid Meeting

The Pre-Bid Meeting was held on 21.05.2024 at 14:00 Hrs. as per schedule no bidder was present in the pre-bid meeting.

iii) Date stipulated for receiving the bid document.

The deadline for submission of online bid was upto 14.00 Hrs. IST on 10th June, 2024.

C) Technical Bid opening.

The online technical bid was opened on 11th June, 2024 at 14:00 Hrs in the Office chamber of Chief Engineer (NH) P.W.D (Roads) in presence of Bid Evaluation Committee members & representatives of bidders. Total 3(Three) nos bids from the following bidders were received through online mode in the portal of <https://eprocure.gov.in/eprocure/app>, namely :-

(i) Bimal Kumar Agarwala,

(ii) P.K Company.

(iii) Midas Construction.

D) Evaluation of Technical Bids.

The qualification information submitted online by the bidders have been examined on the basis of technical qualification criteria laid down in the bidding documents and compiled in the form of a comparative statement – "TABLE FOR EVALUATION OF SUBSTANTIVE RESPONSIVENESS OF TECHNICAL BIDS" to be placed before the Bid Evaluation Committee.

The Technical Bid Evaluation Committee (BEC) held on 12th August, 2024 at 3:00 P.M. in the Office chamber of Chief Engineer (NH) P.W.D (Roads) through VC in presence of all Members and Chief Engineer (NH) P.W.D (Roads), as Chairman of Bid Evaluation Committee (BEC).

The Technical Bid Evaluation Committee (BEC) verified the documents and examined the technical bids & all other relevant papers. The deliberation of the Bid Evaluation Committee is as follows:

i) The bidder, Bimal Kumar Agarwala, has failed to submit the documentary evidence for Mobile Maintenance Unit. Consequently, the bidder is liable to be non-responsive in accordance with Clause 4.1 (j) (1).

- ii) The bidder, P.K Company has failed to submit the documentary evidence for Mobile Maintenance Unit and String Line Set. Consequently, the bidder is liable to be non-responsive in accordance with Clause 4.1 (j) (1) & the C.V. of key personnel was not submitted in accordance with the Cl.4.1 j (2) of ITB (Annexure -I of Qualification Information), the Cvs of Key Personnel have not been submitted and the Road Safety Auditor submitted also does not have the minimum qualification as mentioned in Cl.4.1 j (2).
- iii) The bidder, Midas Construction has failed to submit the documentary evidence for Mobile Maintenance Unit. Consequently, the bidder is liable to be non-responsive in accordance with Clause 4.1 (j) (1) & the C.Vs of key personnel was not submitted in accordance with the Cl.4.1 j (2) of ITB (Annexure -I of Qualification Information) and the Bank Guarantee is upto 31-12-2024 not as per requirement which is 06-01-2025.

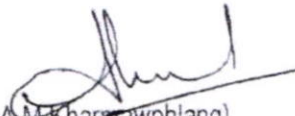
