4. M/s Subhash Chandra Dilliwal, Biaora, Rajgarh, Dist. Bhopal (MP) submitted a representation dated 31.12.2024, in which the bidder provided a scanned copy of evidence regarding the availability of key equipment for construction and maintenance (Clause 4.3 B(b)(i)), either owned, leased, or rented. The bidder also submitted a scanned copy of an experience certificate for works of a similar nature and size for each of the last five years, along with certificates from the concerned officer of the rank of Executive Engineer or equivalent or higher. However, upon review, the evaluation committee found that the experience certificates submitted by the bidder were issued by the competent authority after the bid due date i.e 5.11.2024. As a result, the evaluation committee has not considered these certificates, and therefore, M/s Subhash Chandra Dilliwal, Biaora, Rajgarh, Dist. Bhopal (MP) is deemed non-responsive.
5. The committee opined that the outcome of Technical Evaluation shall be hosted on the web portal thereafter financial bid will be opened.
