MINUTES OF 2nd MEETING OF TENDER EVALUATION COMMITTEE HELD ON 18.09.2024 FOR CONSIDERATION OF TECHNICAL BID FOR THE WORK OF "ONE TIME IMPROVEMENT OF OLD ALIGNMENT FROM KM 42.80 TO KM 60.30 OF NH-2 (OLD NH-150) BYPASSED BY THE NEW ALIGNMENT IN THE STATE OF MIZORAM."

The work under consideration was sanctioned by the Ministry amounting to ₹ 10.38 crore vide F.No. NH-12014/1/2024-RO Guwahati (C.No.233077) Dated 28th February 2024. The estimated civil construction cost of work is ₹ 10.38 crore. The work is proposed under EPC mode as per Ministry's laid down procedures.

2. As per Ministry's Circular No.RW/NH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018 for the works with sanction cost more than ₹ 5.00 to ₹ 100.00 crore, tender may be invited by the State PWD using requisite bidding document and procedure as per Ministry's extant guidelines. 3. The bids for the above mentioned work amounting to ₹ 8.25 crore (amount put to tender) was invited by Chief Engineer, PWD, Highway, Mizoram, Aizawl vide Bid No. 2/RFP/EPC/CE-HW/2024-25 Dt.10.06.2024 and Pre-bid meeting was held at Chief Engineer, PWD, Highway, Mizoram, Aizawl office on 21.06.2024, one bidder i.e., Urban Infraprojects Pvt. Ltd. attended the Pre-Bid Meeting. The bids were opened on 10.07.2024. A total of 4(four) bids were received online from the following bidders:

4. In case of Urban Infraprojects Pvt. Ltd., the bidder submitted Bid Security in the form of Demand Draft valid for 3 months only. As per clause 2.20.1 of RFP, the required validity for Bid Security is "not less than 180 days from the Bid Due date" but their validity of Bid Security submitted was only 91 days. Hence, the bidder was not admitted for evaluation.

5. Based on the documents placed before the Evaluation Committee, the Committee examined the technical bid of the 3(three) admitted bidders in the 1st meeting held on 20.08.2024. In the meeting, based on the technical evaluation and after detailed deliberation, the Committee opined that Tanor Engineering, Itanagar-791111, Arunachal Pradesh may be considered as non-responsive. The remaining two (2) bidders namely, Nidhi Creative Infrastructure Pvt. Ltd., Ambicapatty, Silchar-788001, Assam and SLT Infracon Pvt. Ltd., Hailakandi - 788803, Assam were found to be technically qualified and the Committee recommended opening of their financial bids.

6. The Proprietor, M/s Tanor Engineering, Itanagar-791111, Arunachal Pradesh has submitted Representation vide letter No. Nil dated 26.08.2024 wherein the following points were mentioned:

(i) M/s Tanor Engineering cannot be made to suffer for any procedural lapses of the employer in execution of the work of "Construction of 2-lane road of Potin-Pangin section of NH-13 from km 163.50 to km 206.66 (Package-5) in the State of Arunachal Pradesh Package of Roads and Highways of SARDP-NE" as a sub-contractor under Joint Stock Company Industrial Association "Vozrozhdenie", New Delhi.

The said work was considered under similar work criteria by NHIDCL, New Delhi for NIB No. NHIDCL/Assam/NH-37/J-D-I/2024 dated 16.03.2024 & NIB No. NHIDCL/Assam/NH-37/J-D-II/2024 dated 16.03.2024 and also by Chief Engineer, PWD (Roads), Assam for Package No. AsomMala2.0/West Karbi Anglong/03 dated 01.02.2024.

Clarification ought to have been sought from the Chief Engineer, Highway Zone, PWD, AP, Itanagar and MoRT&H regarding issuance of the approval letter subsequent to the signing of the Sub-Contract Agreement.

(ii) Appendix-IA, Annexure-I was submitted in older format of the RFP.

(iii) Undertaking as per clause 2.2.2.8(ii) certified by statutory auditor is now attached.

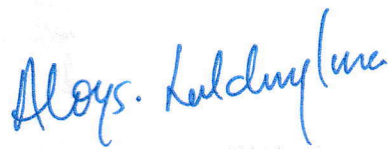
Regarding Sl. No. 6(i), necessary details & required information has been sought from the Chief Engineer, Highway Zone, PWD, AP, Itanagar and NHIDCL, New Delhi for which replies are being awaited. Decision on acceptance of the sub-contract work executed by M/s Tanor Engineering as stated above will be made in future tenders based on the replies, if received.

Regarding Sl. No. 6(ii) & (iii), it is mentioned in clause 2.14.3.1 of the RFP that "No BID can be modified, substituted or withdrawn by the Bidder on or after the BID Due Date & time".

Hence, due to non-submission of the Undertaking as per clause 2.2.2.8(ii) certified by statutory auditor within the BID Due Date & time, the bidder is considered as non-responsive.

7. Based on the above conclusion, the Committee recommends opening of the Financial bids of the two (2) technically qualified bidders.

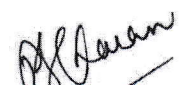
