Minutes of Meeting of Evaluation Committee held on 24.07.2024 for Opening of Technical bids for the work of Construction of Two-Lane with paved shoulder for improvement of geometry from km 50.290 to km 53.330 of NH-353 (Mahasamund-Khariyar Road section) in the state of Chhattisgarh

The above work has been sanctioned by the Ministry for **Rs. 15.11 Crore** vide Job No. NH-353-CG-2021-22-01 vide letter No. RO/CG/AP2021-22/NH-353/ Dated 03.09.2021. The Evaluation Committee is constituted as per Ministry's guideline letter No. RW/NH/24035/4/2008-P&M/PIC Vol.II, Dt. 23.02.2018. The Meeting of the Evaluation Committee for opening of Technical Bids was held on 24.07.2024 in presence of all Committee members.

2. The bids (RFP) for above work amounting to **Rs. 9.83 Crore** (amount put to tender) were invited by Chief Engineer, NH Zone, Raipur, Chhattisgarh with Online Tender ID No. 2024_MoRTH_810884_1, NIT No. 84/CE/NH/TC/44-28/2021 Raipur Date 10.06.2024 as per Ministry's guidelines as well as through e-tendering.

3. The Member Secretary apprised the Evaluation Committee that bid is based on Engineering, Procurement & Construction (EPC) document. The Member Secretary also apprised the Evaluation Committee that NIT was published in newspapers as per Ministry's guideline dated 30-04-2020 and the bid document was uploaded on web site [<https://eprocure.gov.in/eprocure/app>]

4. It was also apprised to the Committee that bids were available for downloading from ministry's e-tendering portal [<https://eprocure.gov.in/eprocure/app>] from 10.06.2024 to 10.07.2024 and the last date of online submission/uploading of bid by the bidder was 10.07.2024. The last date of physical submission of tender documents as per requirement of clause 2.11.2 of RFP was 11.07.2024 (11.00 hrs.). The technical bids were opened on **24.07.2024**. The following bidders participated in the bid of above subjected work:

 - (d) BID Security of Rs. 9.83 Lakhs (Rs. Nine Lakhs Eighty Three Thousand only) in the form of Insurance Surety Bond (in the format at Appendix – IX issued by Insurance Company authorized by Insurance Regulatory and Development Authority of India), Account Payee Demand Draft, Banker's Cheque or Bank Guarantee (in the format at Appendix-II from a Scheduled Bank).
 - (e) Copy of online receipt/ original Demand Draft towards payment of cost of Bid document of Rs. 11,800/- (Rupees Eleven thousand eight hundred only) in favour of ["Pay & Accounts Officer, Ministry of Road Transport and Highway Raipur" payable through bharatkosh] towards cost of Bid document;

 - (g) Bidder shall comply with the provisions of Office Memorandum No. RW/NH-37010/4/2010/PIC-EAP(Printing) dated 22.02.2016 and its subsequent amendments if any issued by MoRT&H (Appendix-VI) regarding Integrity Pact (IP) and the Integrity Pact (IP) duly signed by Authorised signatory shall be submitted by the Bidder with the RFP Bid & shall be part of the Contract Agreement; and
 - (h) An undertaking from the person having PoA referred to in Sub. Clause-(a) above that they agree and abide by the Bid documents uploaded by MoRT&H/NHAI and amendments uploaded, if any.
7. The Evaluation Committee made the following observations during checking of physical submission of bidders in accordance to requirements of RFP for above subjected work :-
- 7.1 The technical evaluation committee found that 02 out of 03 bidders have physically submitted the documents listed at clause 2.11.2 of the RFP.
 - 7.2 The sealed envelope of **M/S. Vedant Construction Co., Abhanpur (C.G.)** was opened and found that the bidder has not submitted Undertaking physically as per clause 2.11.2(h) of RFP and thereafter the Evaluation Committee decided not to open the technical bid of the bidder **M/S. Vedant Construction Co., Abhanpur (C.G.)** as per **clause 2.15.2 and 3.1.1 of RFP.**
 - 7.3 In the view of above the evaluation committee while checking the documents submitted by the bidders found that 02 out of 03 bidders are responsive as per **clause 2.11.2 of RFP.**
8. BID Security Bank Guarantee as submitted by the bidders shall be verified from concerning bank for genuineness.
9. The technical Bids of following 02 Bidders out of 03 bidders who submitted physical documents as per RFP and uploaded the bid documents on the website were admitted for online technical opening by the Evaluation Committee: -

Minutes of Meeting of Evaluation Committee held on 03.09.2024 for Technical evaluation of bids for the work of "Construction of Two-Lane with paved shoulder for improvement of geometry from km 50.290 to km 53.330 of NH-353 (Mahasamund-Khariyar Road section) in the state of Chhattisgarh."

The Evaluation Committee in its previous meeting dated **24.07.2024** opened the technical bids of following 02 bidders for technical evaluation as per criteria mentioned in the RFP:

- (i) **Deepak Pandey**, Shop No.1 FF, PT LLM Complex, Kankali Para, Raipur (C.G.) 492001 Email ID: amit.gudda2001@gmail.com
 - (ii) **M/s Oberoi Construction**, 258-B, NMDC Colony New Rajendra Nagar, Raipur (C.G.) 492001 Email ID: oberoiconstruction@yahoo.com
2. The estimated cost of the project for which bid is invited is less than Rs. 100.00 Cr. and hence Joint Venture is not allowed as per clause 2.2.1 (a) of RFP.
 3. The Member Secretary presented the comparative statement before the Technical Bid Evaluation Committee.
 4. As per the tender called the requirement of **bid capacity** as per 2.2.2.1 is **Rs. 9.83 Crore (Rs. Nine Crore Eighty-Three Lakhs Only)** for individual firm.
 5. The requirement of **Threshold Technical Capacity** as per clause 2.2.2.2 (i) of RFP during last five financial years (2019-20 to 2023-24) for construction of eligible project is **Rs. 7.37 Crore (Rs. Seven Crore Thirty-Seven Lakhs Only)** for individual firm.
 6. Also as per clause 2.2.2.2 (ii) bidders shall have completed at least **one similar work** of 20% estimated project cost i.e. **Rs. 1.97 crores (Rs. One Crore Ninety-Seven Lacs only)** from the Eligible Projects as specified in the said clause.
 7. As per RFP the bidder shall have a minimum **Net Worth** (financial capacity) of **Rs. 0.49 Crore (Rs. Forty Nine Lakhs Only)** as per clause 2.2.2.3 (i) of RFP.
 8. As per RFP the bidder shall have a minimum **Average Annual Turnover** of **Rs. 1.47 Crore (Rs. One Crore Forty-Seven Lakhs Only)** for last five financial years as per clause 2.2.2.3 (ii) of RFP.
 9. In accordance to above fixed criteria of RFP, bid capacity, technical & financial capability of all bidders have been evaluated details of which is attached as '**Annexure-I**' with this document along with the criteria of bidder's as per requirement.
 10. The following observations are made by the evaluation committee in accordance to requirements as per RFP for above subjected work: -
 - a) The bidder **M/s Oberoi Construction**, 258-B, NMDC Colony New Rajendra Nagar, Raipur (C.G.) is found to be **technically non-responsive** as he has neither

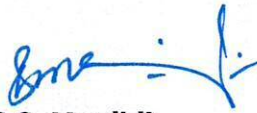

submitted Threshold Technical Capacity and one similar work as per RFP, nor has provided Annual Report of Year 2018-19 & 2019-20. He has also not submitted CA Certified ongoing works and CA certified copy of Civil Construction Turnover as per clause 2.2.2.1 of RFP.

11. It was also apprised to the Committee that **01 bidder out of 02 bidders** fulfill the criteria of Qualification requirements of Bidders as per the condition of bidding documents.
12. The test of responsiveness of all bidder has been checked and following **01 bidder** is found to be responsive as per clause 3.1.6 (Section 3) of RFP -
(i) Deepak Pandey, Raipur (C.G.)
13. It was also apprised to the Committee that all the above bidders have submitted the Bid Securing Bank Guarantee of amounting to **Rs. 9.83 Lacs** in the specified format as per Clause 2.20 and Appendix-II of RFP.
14. It was also apprised to the Committee that the bid securities of the above bidders have been verified from the respective banks.
15. As per clause 2.2.2.1, "The Bid capacity status of the bidder to be updated as on the day before opening the financial bids."
16. In view of above, the Evaluation Committee recommends opening of the Financial Bids of the above technically responsive bidders as per the RFP subject to having available BID capacity (updated as on day before opening of financial bids) more than the total BID value.

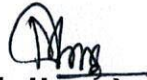
