This is to notify that the Technical Bids were opened for the bidders who have participated in the bid for the subject mentioned work on e-procurement portal on 12.07.2024 after 14.00 hrs. at PWD Building, Dr. B.C. It is to inform that 2 (Two) bidders out of above 4(Four) bidders do not fulfill the qualifying criteria as per ITB of the Tender Documents. Following deficiencies have been observed from submitted documents of bidders are listed below and the Evaluation Committee declared as **technically Non-Responsive**.

(i) **BLACK DOWN CO-OPERATIVE LABOUR CONTRACT AND CONSTRUCTION SOCIETY LTD**

a) All the works submitted by the bidder are on VR or MDR. There is no similar nature of work executed on NH or SH as per Clause No. 4.5.3(b) of ITB.

Accordingly, the bidder is considered as **Non Responsive**.

(ii) **RASHBEHARI SEN**

a) "COST OF BID DOCUMENT" not submitted as per Clause No. 2 of IFB (INVITATION FOR BID).

b) "BID SECURITY" not submitted as per Clause No. 3 of IFB (INVITATION FOR BID).

Accordingly, the bidder is considered as **Non Responsive**.

It is also to inform that, the following 2 (Two) bidders have been qualified all the technical and financial requirements as per ITB of the Tender Documents and considered as 'Responsive & Technically Qualified' Bidders:-

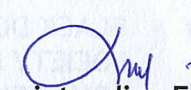
