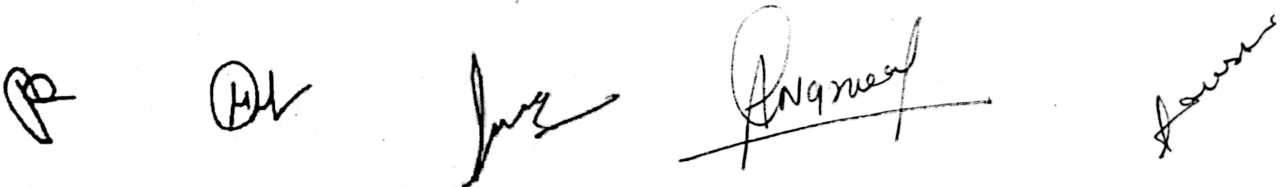

EE, Punjab State PWD(B&R), Ferozepur, Member Secretary informed the committee that bids for the subject work were opened on 26.07.2024 and three agencies have submitted their bids on Infracon Portal. However, only two firms have uploaded their bids on CPPP Portal. Details are as :-

4. Since, the firm (M/s Engineering Consultancy Services), has not uploaded their bids on CPPP Portal, therefore, committee decided not to consider their bids. The bids of other two firms were evaluated broadly in 1st meeting and following observations were made.



Sr. No.	Name of Firm	Observation
1.	M/s Almondz Global infra Consultant Limited in JV with Ekam Venture in association with T & TS Engineering Consultancy India Pvt Ltd.	It was observed that proposed Team Leaders do not have mandatory training certificate in "Preparation of Feasibility study and DPR for Highways Projects" required as per minimum, qualification RFP. Further, clause 5.2 of RFP states that the CV of the proposal team leader should score atleast 80% marks otherwise the entire proposal shall be considered to have failed in the evaluation of Technical Proposal. Therefore, both the firm are found "Non-Responsive" as per the conditions stipulated in RFP.
2.	M/s Armenge Engineering Pvt. Ltd in association with shreeMahamai Infra Consultant Pvt. Ltd.	

5. In view of the above, Evaluation committee recommended to annual the bids and re- invite the bid after giving opportunity to bidders to respond, in case, they have objection.
6. Meeting ended with Vote of thanks to chair.



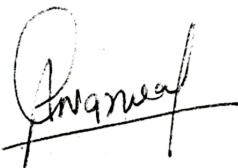

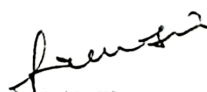
