

MINUTES OF MEETING OF FINANCIAL EVALUATION COMMITTEE HELD ON 16-10-2024 FOR THE WORK "Special Repair on NH-305 Sainj Lohri Aut road, construction of retaining walls between Km. 3/00 to 8/00 and Km 64/00 to 94/800 in the State of Himachal Pradesh".

1. The meeting of the Evaluation Committee for the evaluation of financial bids for the aforesaid work was held on 16-10-2024. Following officers were present in the meeting:-

2. The financial bids for the above work were opened on 10-10-2024. The quoted bid amount of responsive bidders are as under:-

The bidder M/s Bhambhu Builders, is the L-1 bidder and the amount quoted by the lowest bidder is Rs. 10,20,53,000/- (Rupees Ten crore twenty lacs & fifty three thousand) only including GST and other taxes that the contractor will have to pay for the performance of the contract. The bid amount quoted by the lowest bidder below the estimated civil cost of the project is as under:-

4. The bidder M/s Bhambhu Builders, is declared as the selected bidder as he has quoted lowest price as per clause 3.3.1 of Sction-3 of EPC agreement uploaded with tender documents.

Since the bid price quoted by the lowest bidder is 25.25% below the estimated civil cost, as such as per clause 2.21 of RFP based upon MoRTH Circular No. NH 37015/01/2022-H (Comp No. 212632) dated 31 Aug., 2022, the committee decided to take additional Performance security amount to Rs. 12.15 lacs. (Restricted to max. 3%) in addition to performance security, for which the case shall be submitted to the Competent Authority for approval before award.
