

MINUTES OF MEETING OF FINANCIAL EVALUATION COMMITTEE HELD ON 23-08-2024 FOR THE WORK "Maintenance works and activities (PBM) on section from km.65/0 to km 76/0 of NH No. 154 A in the State of Himachal Pradesh".

2. The financial bids for the above work were opened on 21-08-2024. The quoted bid amount of responsive bidders are as under:-

3. The bidder **M/s R.K. Mahajan Govt. Contractor**, is the L-1 bidder and the amount quoted by the lowest bidder is Rs. 6,42,07,784/- (Rupees Six crore forty two lacs seven thousand seven hundred & eighty four) only excluding GST. The %age of quoted amount of the lowest bidder below the estimated civil cost of the project is as below:-
