

Minutes of the Meeting dated 17-07-2024 for Financial Evaluation for the WORK "SHORT TERM MAINTENANCE OF JALANDHAR HOSHIARPUR ROAD NH-03 FROM KM 49.200 TO 58.360 IN THE STATE OF PUNJAB.

(Amount put to tender: Rs 109.74 Lakhs Without GST)

Meeting of the Financial Evaluation Committee was held on dated 17-7-2024 in the office of the Superintending Engineer, National Highways Circle, PWD B&R Br., Amritsar to evaluate the financial bids as received from the intended bidders as per standard DNIT document of the Ministry. At the onset, Executive Engineer, National Highways Division, Hoshiarpur informed the committee that administrative and financial sanction of the instant project amounting to Rs. 140.47 Lakh issued vide Ministry's letter No: RW/CH/PB/W(83)/2024/1647 dated: 30.01.2024. Accordingly, bid was invited by the Executive Engineer through Online Mode vide Tender Notice No: 02 dated 01.07.2024 with estimated project construction cost Rs. 109.74 Lakhs (Without GST). As per DNIT Original documents in hard copy was received from three number bidders on dated 15-7-2024. The technical bid was opened on 16-7-2024 & bid was received from 1)Rajiv Kumar Aggarwal Hoshiarpur, 2)Rakesh Singh Contractor 3)M/S Satish Kumar Aggarwal. Executive Engineer, National Highway Division, Hoshiarpur informed the committee that the above mentioned three bidders had uploaded their bid on the tender e-portal, as per the guidelines of Ministry.

The Executive Engineer, National Highway Division, Hoshiarpur has informed that the Evaluation Committee vide Minutes of Meeting dated:17.07.2024 has qualified the technical bids of following bidder and the Committee further recommended to open the Financial Bids of these qualified bidders.

The Executive Engineer, National Highway Division, Hoshiarpur has further informed that after uploading the proceedings of technical evaluation by the Committee on the web site, the financial bids of this work have been opened online on dated 17-7-2024 at 3 PM. The rates quoted by the bidders in this financial bid are as under:-

The Executive Engineer, National Highway Division, Hoshiarpur has further informed the committee that the final position of the rates as per Financial Statement is as under:-

1. DNIT Cost. : Rs.1,09,73,996/-
2. Lowest Agency Cost (L-1) : Rs.80,15,407/-
3. Cost less than the amount put to tender : Rs.29,58,589/- or 26.96% Saving

It is submitted that rates quoted by the bidder is 26.96% less against the amount put to tender. So, keeping in view of the above reasons, the Evaluation Committee recommends to issue the Letter of Award in favour of Lowest Bidder i.e. M/S Satish Kumar Aggarwal, Amritsar at quoted price of Rs.80,15,407/-
