

MINUTES OF THE MEETING HELD DATED: 17.07.2024 FOR EVALUATION OF TECHNICAL BIDS FOR THE WORK "SHORT TERM MAINTENANCE OF JALANDHAR HOSHIARPUR ROAD NH-03 FROM KM 49.200 TO 58.360 IN THE STATE OF PUNJAB.

Meeting of the Technical Evaluation Committee (Constituted by the Chief Engineer (NH), Punjab, PWD B&R, Patiala office Memo No: 3033/NH dated: 18.07.2016) held on Dt. 16.07.2024 in the office of Superintending Engineer, National Highway Circle, PWD B&R Br., Amritsar to evaluate the technical bid as received from Intended bidders as per the Standard SBD document of the Ministry. 2. At the outset the Superintending Engineer, National Highway Circle, PWD B&R Br., Amritsar welcomed the participants. Executive Engineer, National Highway Division, PWD B&R, Hoshiarpur appraised about the technical, administrative and financial sanction of the instant project amounting to Rs. 140.47 Lakh issued vide Ministry's letter No: RW/CH/PB/W(83)/2024/1647 dated: 30.01.2024. Accordingly, bid was invited by the Executive Engineer through Online Mode vide Tender Notice No: 02 dated 01.07.2024 with estimated project construction cost Rs. 109.74 Lakhs (Without GST); Bid Security Rs. 1,09,740/-, Tender Fee Rs. 11,800/- and Contract period of 12 Months including rainy season.

iii M/S Satish Aggarwal & Co.,

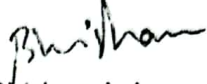

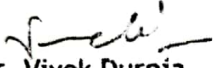
