

5th Minutes of the meeting of the Evaluation Committee held on 07.01.2025 for Evaluation of Technical bids for the work of "Performance Based Maintenance Contract (PBM) work from km 105.00 to km 145.632 of NH - 31C (New NH-17) under NH Division - IX, in the district of Jalpaiguri, West Bengal during the year 2023-24 (Job No. 017/WB/2023-24/530) – 2nd call". [eTender ID : 2024_MoRTH_814357_1]

Sanctioned Cost: Rs.67.4499 Cr. and Cost put to tender: Rs.59.1588 Cr. including 18% GST
Bid Package No. : e-RFP No.4 of 2024-25 of Superintending Engineer, NH Circle-III

1. In pursuance of the Administrative Approval with Technical and Financial Sanction was accorded by the Ministry vide letter file no. NH-12014/123/2023-RO-KOL dated 19.12.2024 for the above mentioned PBM work, on-line bid was invited for 2nd call by the Superintending Engineer, N.H. Circle No.III, P.W. (Roads) Directorate on behalf of Chief Engineer, NH Wing through the e-tendering portal <https://eprocure.gov.in/eprocure/app> for the subject work under e-RFP No.4 of 2024-25 of Superintending Engineer, NH Circle-III dated 01.07.2024 after cancellation of tender in 1st call vide MoM of the Evaluation Committee dated 27.06.2024. Technical Bid was opened from the web portal: <https://eprocure.gov.in/eprocure/app> on 23.08.2024 after 11:00 hrs in the office of the SE, NH Circle-III and it was found that following 9(nine) bidders have participated in the bid:

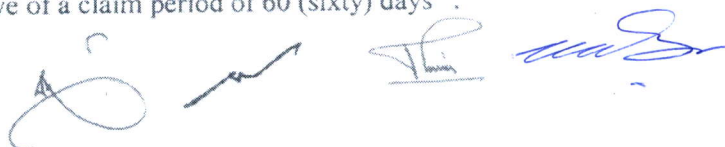

2. Evaluation Committee evaluated all the Technical Bids during its meeting held on 22.10.2024, 05.12.2024, 13.12.2024 & 27.12.2024 based on the requisite documents furnished to substantiate the Threshold Technical Capacity in accordance to Clauses 4.3(i), 4.6(i) and 4.6(ii), Mandatory Technical Experience from the Eligible Projects in Category 1 and / or Category 3 specified in accordance to Clause 4.6, Financial Capacity in accordance to clauses 4.4 of the RFP respectively and Bid Capacity in accordance to Clause no. 4.2 of the RFP, on receipt of undertakings as per clause 4.1 (j) (1) & (2) for List of Equipment & Availability of personnel and noticed that out of 9(nine) participating bidders as mentioned in para-1 above.

3. Based on the detailed evaluation, the Evaluation Committee recommends following Bidder as "Responsive & Technically Qualified" vide MoM dated 27.12.2024:

- i) M/s. Vinod Kumar Jain
- ii) Himalayan Road Construction Pvt. Ltd.
- iii) Dooars Construction Company
- iv) Stone Concern Infrastructure Development Pvt. Ltd.
- v) Dipankar Mallik
- vi) M/s. Niranjan Paul & Co.
- vii) RSM Infra Projects

4. After Publication of result for technical evaluation, a representation was received from "S S Civil Construction Pvt Ltd" on 02.01.2025 & 06.01.2025 regarding the validity of Bid Security submitted by them. The agency represented that they had submitted Bid with validity more than 150 days from Bid Due date which is in conformity with the RFP Section -4, Form of Bank Guarantee for Bid Security which states in Para -4 that "This Guarantee shall be irrevocable and remain in full force for a period of 150 (one hundred and fifty) days from the BID Due Date inclusive of a claim period of 60 (sixty) days".



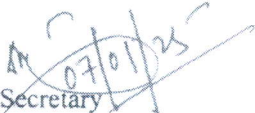
4.1 Committee took note of fact that the agency had submitted Bank Guarantee with validity period up to 23.01.2025 and claim period up to 24.03.2025. validity Period is more than 150 days and satisfies the provision of Section-4 of RFP . As such, Committee unanimously decided that agency **S. S. Civil Construction Pvt. Ltd** may be declared as **Responsive and Technically Qualified**.

4.2 Based on the detailed evaluation, the Evaluation Committee recommends following 8(Eight) Bidders as "Responsive &Technically Qualified" :

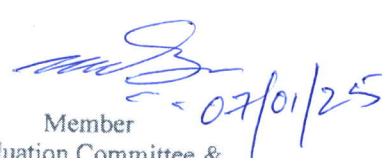

- (viii) S. S. Civil Construction Pvt. Ltd.

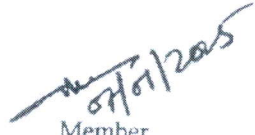

In view of the above, the Evaluation Committee recommends opening of Financial Bids of the above 8(Eight) bidders "Responsive & Technically Qualified" after online publication of results of technical evaluation. However, the technically qualified bidder may be requested to submit the updated value of Bid Capacity, before opening of financial bids as per clause 2.2.2.1 of RFP.
