Preamble:-

The Ministry of Road Transport and Highways has approved 295 Nos of works amounting to Rs.1385.60 Cr vide letter No.RW/BNG/GENL/CRIF/121/2020 Dtd:-12.03.2024. The above works are included in the approved list vide SL No.268 with a sanctioned cost of Rs.600.00 Lakhs.

Further, the Government of Karnataka vide letter No.PW 06 CRF 2024(E), Bengaluru Dtd:-29.08.2024 has accorded Administrative approval for the same by assigning Job No.CRIF-KNT-2023-24-268.

Technical sanction has been accorded by the Chief Engineer, National Highways, Bengaluru vide CER No.43/2024-25.

Accordingly, tender was called for the said work by the notification No: 04/2024-25, Date:-06.09.2024 through CPP portal <https://eprocure.gov.in> by the Executive Engineer, NH Division, Bengaluru.

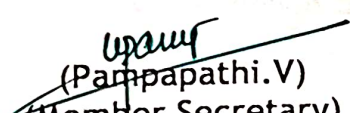
CONCLUSION:-

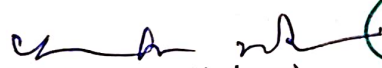
Further, Instructions were issued to the Executive Engineer, National Highway Division, Bengaluru to open the financial bids of the responsive bidders as per the departmental procedures.

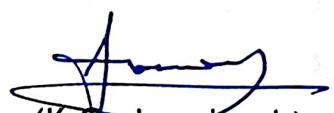
