

MINUTES OF MEETING OF THE TENDER EVALUATION COMMITTEE HELD FOR CONSIDERATION OF THE TECHNICAL BID FOR THE WORK "SHORT TERM MAINTENANCE CONTRACT ON NH-502A (KMMTTP) BETWEEN KM 34.920 TO KM 60.700 IN THE STATE OF MIZORAM. (JOB NO. RW/GHT/NH-502A/MZ/STMC/2024-25/5)". (2nd Call)

The Tender Evaluation Committee for Re-NIT No. 5/STMC/CE-HW/2024-25 Dt. 17.10.2024 had its meeting on **Dt.20.11.2024** to evaluate the Technical Bids of the work mentioned above.

2. The particulars of NIT for 2nd Call are as follows:

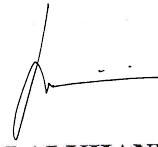
- i) Date of Downloading : 17th October, 2024 to 2nd November, 2024 (12:00 hrs)

3. The cost of work put to tender is **₹ 99.38 lakhs**. Accordingly, the amount of bid security for the work is **₹ 1,99,000.00**.
4. The online technical bids submitted by the bidders were opened on 4th November, 2024 in the Office of the Chief Engineer, PWD, Highway, Mizoram, Aizawl. The Committee observed that only 1 (one) bidder viz. Nidhi Creative Infrastructure Pvt. Ltd., has uploaded their bids in the e-procurement portal for the above work until the last day fixed for submission of bids.
5. The single bidder has submitted Bid Security for the requisite amount and validity period as mentioned in the bidding document.

6. The Evaluation committee examined the Bids of the single Bidder and after details deliberation found the single bidder as Technically Responsive and recommends for opening of Financial Bid for the work "Short Term Maintenance Contract on NH-502A (KMMTTP) between km 34.920 to km 60.700 in the state of Mizoram" (Job No. RW/GHT/NH-502A/MZ/STMC/2024-25/5).



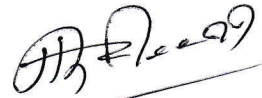

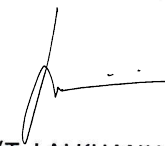
