

MINUTES OF MEETING OF THE TENDER EVALUATION COMMITTEE HELD FOR CONSIDERATION OF THE FINANCIAL BID UNDER RE-NIT NO. 6/STMC/CE-HW/2024-25 Dt. 17.10.2024 FOR THE WORK "SHORT TERM MAINTENANCE CONTRACT ON NH-502A (KMMTTP) BETWEEN KM 60.700 TO KM 87.510 IN THE STATE OF MIZORAM. (JOB NO. RW/GHT/NH-502A/MZ/STMC/2024-25/6)"

Estimated Amount put to Tender : ₹ 106.31 lakhs

The Tender Evaluation Committee had its meeting on 21.11.2024 to evaluate the Financial Bids of the work mentioned above.

1. The Ministry had conveyed approval to the following work as per the details given below:-

2. The technical bid was evaluated on 20.11.2024 and one(1) bidder was responsive, namely

i) Nidhi Creative Infrastructure Pvt. Ltd., Silchar, Assam.

3. The cost of work put to tender is ₹ 106.31 lakhs. The bid security amount for the work is ₹ 2,13,000.00. The bidder has submitted the requisite bid security.

4. The financial bids of the above 1(one) technically responsive bidder was opened on 20.11.2024. The quoted price of the bidder was downloaded. The quoted bid price is as tabulated below :

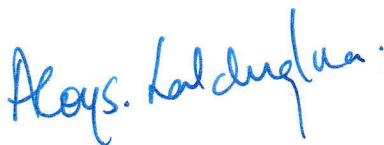
5. The committee examined the financial bid of the 1(one) technically qualified bidder on the basis of documents placed before the committee and found the bid price of Nidhi Creative Infrastructure Pvt. Ltd. i.e ₹ 1,06,31,741.00 (at par with the cost of work put to tender) to be the lowest.

6. The e-portal generated BOQ summary details of financial bid of the bidder is appended as Annexure-I and Comparative statement of detail item wise BOQ of the bidders generated by computer appended as Annexure-II.

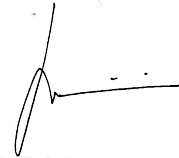
7. The tender under consideration was floated on Dt.17.10.2024 for which there was one (1) bidder and the technical bid of this tender was opened on Dt. 04.11.2024.

8. The Financial bid was opened on Dt. 20.11.2024 and the bid amount received from the single bidder is at par with the amount put to tender. The e-portal generated BOQ of the lowest bidder (L1) is appended as Annexure-III.

9. In view of the above, the committee recommends award of the work "Short Term Maintenance Contract on NH-502A (KMMTTP) between km 60.700 to km 87.510 in the state of Mizoram. (Job No. RW/GHT/NH-502A/MZ/STMC/2024-25/6)" to the lowest bidder Nidhi Creative Infrastructure Pvt. Ltd. at his quoted amount of ₹ 1,06,31,741.00.
