With the above details the technical bids of the said Three bidders have been placed before the technical bids evaluation committee by the Member Secretary for kind approval.

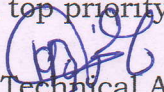

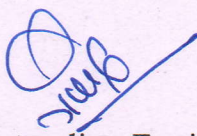
The committee decided and directed to EE NH Division, Kalaburagi to recall the tender on top priority considering as a short term.

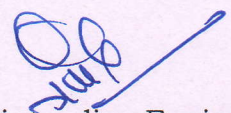
