No any queries were received on the scheduled date (15-10-2024) of pre-bid meeting of the said work thorough online or offline.

As per scheduled technical bids of the work were opened on 5-11-2024 and two bidders namely : 1) M/s R.G Patel Constructions Islamabad Colony Kalburgi 2) M/S SABA Constructions, M.G Road Kalaburgi - have responded and preliminary evaluated statement is prepared w.r.t. qualification criteria & NIT and are as under.

Contractors' Registration No, Tender Fee, Bid Security (EMD), Line assets/Credit facilities, Annual Turnover reports, Single largest work, quantity executed in any one year from last five years (2019-20 to 2023-24), Plant & Equipments, Bid Capacity of the said work as per bid document of STD KW-4 and confirmation of EMD instrument, Liquid assets/Credit facilities, Annual Turnover reports, Single largest work have been obtained from the concerned.

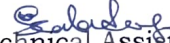

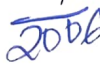

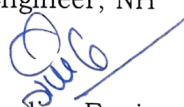
