Preamble

Ministry of Road Transport & Highways, New Delhi letter in the letter No.RW/BNG/GENL/CRF/121/2020/ dated:12.03.2024 has approved the work Improvements road off from SH-61 to Deodurga-Amarapura-Bhogavathi-Hirekotnekal-Ayanur--Talur-Ballari-Rupanagudi-Chellagurki road (SH128) from Km 119.85 to 130.00 in Siruguppa taluk of Ballari District.(Job No:CRIF-KNT-2023-24-245) for an amount of Rs.600.00 lakhs and the Secretary, PWD, Govt of Karnataka in the Government order ಸಂಖ್ಯೆ:ಬಿಎಚ್‌ಐ 6 ಸಿ ಆರ್ ಎಫ್ 2024 (ಇ), ಬೆಂಗಳೂರು, ದಿನಾಂಕ: 29-08-2024 has accorded administrative approval.

Technically sanctioned by the Chief Engineer, National Highways, Bengaluru assigning the sanction No. As CER No.112/2024-25 Dt.02.09.2024 for Rs.600.00 lakhs.

Tender was called for the said work by the notification No:607, Date:10-09-2024 through CPP portal <https://eprocure.gov.in> and Corrigendum was issued for extension of time vide letter No: 673 Date:21-09-2024 by the Executive Engineer , NH division Chitradurga. Amount put to tender is Rs.485.56 Lakhs and the calendar of events were as here under.

The Technical Bids were opened on 21.10.2024 , 4 bidders have participated in the tender as follows and except the bidders Sri.Dilip Kumar Saklecha and M/s Srinivas Infra Projects, the other 2 bidders have submitted original E.M.D within the stipulated date and time of opening of tender as specified in the Notice Inviting tender. Bidder's documents were downloaded and considered for evaluation

3. Sri.Dilip Kumar Saklecha
4. M/s Srinivas Infra Projects

The meeting of the Technical Bid Evaluation committee constituted vide letter dt.31.07.2024 comprising the following members was convened on 08-01-2025 at 3.00 P.M in the chambers of the CE, N.H, Bangalore, to evaluate the technical bids received for the above said work.

The technical bid documents substantiating the qualification criteria indicated in the KW-4 was verified and the committee has resolved the qualification criteria's of bidders as under:

TECHNICAL EVALUATION

1. Sri.M.Rajgopal Reddy

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division,Chitradurga. It has been noticed that bidder has submitted (1) the bid security, 2) Annual turnover report as per Sec 2 Clause 3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bankers certificates for credit facilities as per clause 3.3b, and (5) Plant & equipment capabilities as per clause 3.3(a).

The Confirmation pertaining to BG, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents. Hence the documents submitted by the bidder satisfies the conditions as per the Bid Document and is technically responsive.

2. M/s Siddarameshwara Constructions

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Chitradurga. . It has been noticed that bidder

has submitted (1) the bid security, 2) Annual turnover report as per Sec 2 Clause 3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bankers certificates for credit facilities as per clause 3.3b, and (5) Plant & equipment capabilities as per clause 3.3(a).

The Confirmation pertaining to BG, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents . Hence the documents submitted by the bidder satisfies the conditions as per the Bid Document and is technically responsive.

3. Sri.Dilip Kumar Saklecha

The committee verified the downloaded documents as furnished by the Executive Engineer, National Highway Division,Chitradurga. It has been noticed that bidder has submitted (1) the bid security, 2) Annual turnover report as per Sec 2 Clause 3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bankers certificates for credit facilities as per clause 3.3b, and (5) Plant & equipment capabilities as per clause 3.3(a).

But bidder has submitted insufficient quantity as per clause 3.2(c), hence the documents submitted by the bidder does not satisfies the conditions as per the Bid Document and also as per the report of the Executive Engineer NH division Chitradurga , the bidder has not submitted the Hard copies for the EMD in the form of Bank Guarantee , Line of Credit and Bharatkosh Receipt submitted online by the bidder and hence is technically non responsive.

4. M/s Srinivas Infra Projects

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division,Chitradurga. It has been noticed that bidder has submitted (1) the bid security, 2) Annual turnover report as per Sec 2 Clause 3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bankers certificates for credit facilities as per clause 3.3b, and (5) Plant & equipment capabilities as per clause 3.3(a).

As per the report of the Executive Engineer NH division Chitradurga , that the bidder has not submitted the Hard copies for the EMD in the form of Bank

Guarantee, Line of Credit and Bharatkosh Receipt submitted online by the bidder and hence is technically non responsive.

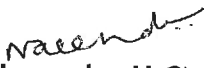
COMMITTEE CONCLUSION:-

As the bids submitted by the bidder's Sri.M.Rajgopal Reddy and M/s Siddarameshwara Constructions are in line with the uploaded bid documents the committee considered both the bidders as responsive .

Whereas Sri.Dilip Kumar Saklecha and M/s Srinivas Infra Projects is considered as non responsive by the committee, since as per the report of Executive Engineer NH division Chitradurga , both the bidders have not submitted the Hard copies for the EMD in the form of Bank Guarantee , Line of Credit and Bharatkosh Receipt submitted online by the bidder.

Instructions were issued to the Executive Engineer, National Highway Division, Chitradurga to open the financial bids of the responsive bidders as per the departmental procedures.
