MINUTES OF THE TECHNICAL EVALUATION COMMITTEE MEETING HELD ON 21-11-2024 IN THE CHAMBER OF CHIEF ENGINEER, NATIONAL HIGHWAYS, BANGALORE TO EVALUATE THE BIDS RECEIVED FOR THE WORK PACKAGE-1 WORKS.

PACKAGE-1

1. "Resurfacing of Halageri-Hulikal road SH-26 from km 70.80 to 72.50 and km 79.60 to 81.40 in Shivamogga Taluk (Job No. CRIF-KNT-2023-24-167)"
2. "Resurfacing of Kuppali-Hirekerur Road SH-148 from Km 52.60 to Km 54.000 & Km 88.00 to Km 89.90 in Shivamogga Taluk Shivamogga Dist t.(Job No.CRIF-KNT-2023-24-168)"
3. "Re-surfacing to road from Bhadravathi to Sasvehalli (HonnaliTq Boarder) via Holehonnur, Sidlipura, Sanyasikodmagge, Nagasamudra, Mangote, Anveri, Nimbegundi&SydarKallahalli road from ch:23.10 to 26.10 Km in BhadravathiTq." approved under CRIF 2023-24 (Job No. CRIF-KNT-2023-24-169)

Preamble:-

The Ministry of Road Transport and Highways has approved 295 Nos of works amounting to Rs.1385.60 Cr vide letter No.RW/BNG/GENL/CRIF/121/2020 Dtd:-12.03.2024. The above works are included in the approved list vide SL No.167,168 & 169 with a sanctioned cost of Rs.600.00 lakhs.

Further, the Government of Karnataka vide letter No.PW 06 CRF 2024(E), Bengaluru Dtd:-29.08.2024 has accorded Administrative approval for the same by assigning Job No. CRIF-KNT-2023-24-167, CRIF-KNT-2023-24-168 & CRIF-KNT-2023-24-169.

Technical sanction has been accorded by the Chief Engineer, National Highways, Bengaluru vide CER No.72/2024-25, 51/2024-25, 26/2024-25.

Accordingly, tender was called for the said work by the notification No: EE/NHD/SMG/AE-1/CRIF/NIT-2/2024-25/963, Date:-18.09.2024 through CPP portal <https://eprocure.gov.in> by the Executive Engineer, NH Division, Shivamogga.

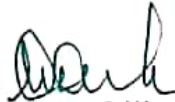
CONCLUSION:-

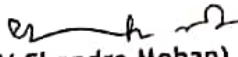
After detailed deliberations, the technical bid evaluation committee has resolved to consider the following bids as technically responsive.

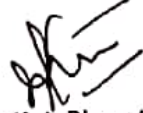

3. National Infrabuild Private limited, Ibrahim Shereef, Class I Contractor, A.P Road, Thirthahalli Taluk, Shivamogga.

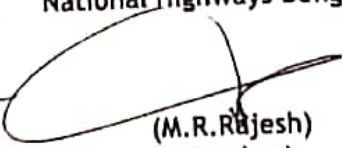
Further, Instructions were issued to the Executive Engineer, National Highway Division, Shivamogga to open the financial bids of the responsive bidders as per the departmental procedures.

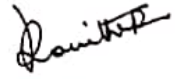
