

Minutes of the meeting of the Evaluation Committee held on 24.01.2025 for Evaluation of Technical bids for the work of "Restoration work of damaged road bench at 3.50 Km of NH-10, damaged due to heavy rain from 26th to 28th September, 2024 under N.H. 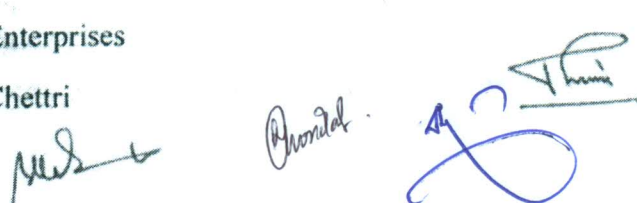
1. Online bid for the subject work was invited by the Superintending Engineer, N.H. Circle No.III, P. W. (Roads) Directorate through e-tendering portal <https://eprocure.gov.in/eprocure/app> vide eNIB No.16 of 2024-25 dated 15.10.2024 under single stage two cover system on SBD Mode. After receiving the Bid Security and other original bid documents physically within due date and time, Technical Bid was opened from the web portal: <https://eprocure.gov.in/eprocure/app> on 19.11.2024 in the office of the SE, NH Circle-III and it was found that following 3(three) bidders have participated in the tender.

- (i) M/s. Sunrise Enterprises
- (ii) M/s. Sukdeo Chettri
- (iii) M/s. Krishna Gupta

Superintending Engineer, NH Circle-III apprised the members of the Evaluation Committee that the financial instrument submitted by the bidders towards Bid Security is found in order except the bidder namely 'M/s. Krishna Gupta' has not submitted the hard copy of Original Bid Security and cost of Tender fee physically. **Accordingly, the Bid of 'M/s. Krishna Gupta' is hereby rejected and treated as non-responsive bid.**

2. All the online technical bids received from the 3(three) bidders as mentioned in para-1 except the bidder namely 'M/s. Krishna Gupta' have been scrutinized by the Evaluation Committee based on the requisite documents furnished by the bidders to substantiate credential in respect of (i) Execution of similar work (ii) Bid Capacity (iii) Av. Annual Turnover for last 5 years respectively in accordance to qualification criteria and terms and condition of the Standard Bidding document and found in order. Based on the detailed evaluation, the Evaluation Committee found following 2(two) Bidders as **"Responsive & Technically Qualified"**:

- i) M/s. Sunrise Enterprises
- ii) M/s. Sukdeo Chettri



3. In view of the above, the Evaluation Committee recommends opening of Financial Bids of the above 2(two) "Responsive & Technically Qualified" bidders at the earliest after online publication of results of technical evaluation.

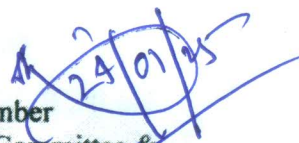

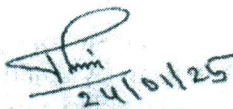
