No any quaries were received on the scheduled date (10-10-2024) of pre-bid meeting of the said work thorough online or offline.

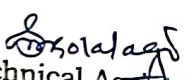

With the above details the technical bids of the said Two bidders have been placed before the technical bids evaluation committee the Member Secretary for kind approval.

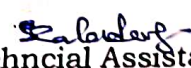
After detailed verification of the documents w.r.t. above qualification criteria the Executive Engineer has tabulated the Responsive and Non responsive bidders.

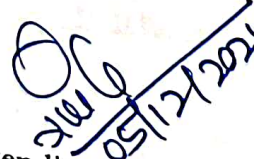
