Preamble:

Ministry of Road Transport & Highways, New Delhi letter in the letter No.RW/BNG/GENL/CRF/121/2020, dated 12.03.2024 has approved the work of "Strenthening of Alur - Siddapura (Somavarapete Taluk) to Sathanur (on NH 948) from Ch. 129.07 KM to 139.070 KM in Nagamagala Taluk approved under CRIF 2023-24 - [Job No: CRIF-KNT-2023-24-286]" for an amount of Rs.600.00 lakhs and the Secretary, PWD, Govt of Karnataka in the Government order ಸಂಖ್ಯೆ: ಬಿಪಿಎಂ 6 ಸಿ ಆರ್ ಎಫ್ 2024 (ಇ), ಬೆಂಗಳೂರು, ದಿನಾಂಕ: 29-08-2024 has accorded administrative approval.

The Technical Bid documents substantiating the qualification criteria indicated in the KW-4 tender document has been verified by the Committee and responsiveness of the bidders as per Technical Evaluation is as follows;

TECHNICAL EVALUATION:

1. M/s YSY Constructions .Mysore.

The Committee verified the downloaded Technical Bid documents of the bidder as furnished by Executive Engineer, National Highway Division, Bengaluru. The Committee observed that, the said bidder has furnished the required documents which are satisfying the tender qualification criteria (1) the bid security, 2) Annual turnover report as per Clause 3.2 (a) of Sec-2, (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) Banker's certificates for credit facilities as per clause 3.3b, and (5) Plant & equipment capabilities as per clause 3.3(a) of tender document.

Further, the Confirmation pertaining to EMD, Work done and Line of Credit has been obtained by the Executive Engineer, National Highway Division, Bengaluru and are in line with the submitted Bid documents. Hence, the Committee opined to consider the bid as technically responsive.

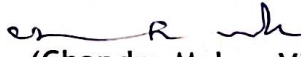

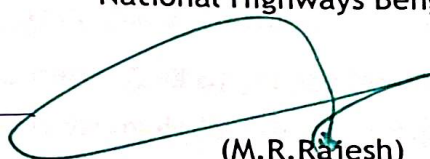

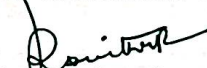
