

Minutes of meeting of Evaluation committee held on date 13/05/2025 for evaluation of Technical Bids in light of the directive issued by Govt. of Gujarat.

1. Meeting of Evaluation Committee was held on 13/05/2025 in the Chamber of Chief Engineer (NH) & Addl. Secy., R&B Deptt., New Sachivalaya, Gandhinagar for evaluation of financial bids of the work of Consultancy Service for proof checking, assisting supervision of the work, quality control of work for Up-gradation and strengthening to 2 lane + PS from Km. 95/500 to km. 129/775 of NH-168G (Idar-Bhiloda-Samlaji Section) in the State of Gujarat (Length = 34.275 Km) (Job No. 168/GJ/ 2022-23/687). 2. The Committee was apprised that in Evaluation Committee Meeting held on 06/03/2025 at Superintending Engineer, National Highway Circle, Gandhinagar following 2 (Two) bidders were declared technically responsive out of 2 (Two) bidders. The details of technically qualified bidders are as under :

3. Accordingly, online financial bids of above 2 (Two) bidders were opened on 10/03/2025, 16.15 Hrs. at NH Circle, Gandhinagar. The following are the bid prices offered by the particulars bidders :-

4. The lowest tendered amount of Rs. 1,73,91,555.12 has been quoted by Global Infra Solutions JV Eagle Infra Projects Consultancy Services, Bhopal which is 10.14% Below the amount put to tender.

5. Financial bid was opened on dt. 10/03/2025 at that stage both agency were qualified but the agency M/s. Thoughts Consultants Jaipur Pvt. Ltd., Jaipur has represented vide his letter dt. 24/03/2024 (Copy attached) and he brought to attention that the first lowest agency M/s. Global Infra Solutions joint venture with Dhruv Consultancy Service Ltd. in association with MS Consultant was debarred for two year and prohibited from participating in future bids vide No. NHAI/11021/16/PIU-K'giri/2023/834/33/(243693) dt. 11/03/2025, so in connection of this order the first lowest agency is to be considered disqualified and not to be considered for award of this work.

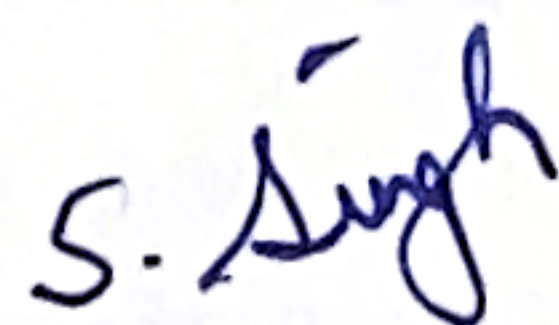
6. In view of NHAI, New Delhi debar order on dt. 11/03/2025, the first lowest agency M/s. Global Infra Solutions JV Eagle Infra Projects Consultancy Services, Bhopal is being considered disqualified. The second lowest agency who is 56.60% above the amount put to tender is not willing full to negotiate and reduce his tendered amount. Hence it is decided to reject this bid and re-invite fresh tender for this work.
