The work under consideration has been approved by the Ministry amounting to Rs.205.00 Lakhs vide Ministry letter No.NH-12/11/2024-RO Guwahati dated 14th November 2024. The estimated amount put to tender is Rs. 188.99 Lakhs.

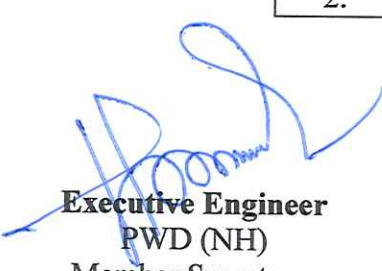
