

Minutes of the Meeting of Evaluation Committee held on 20th November, 2024 at 1500Hr at the Office of the Chief Engineer PWD (NH) for the work, "Special Repair 2024-25 on NH-02 (Old NH-61) from Km 127.160 to 134.010 Km and NH-702D from Km 0.300 to 59.800 Km in the State of Nagaland."

The work under consideration has been approved by the Ministry amounting to Rs.173.42 Lakhs vide Ministry letter No.NH-12/12/2024-RO Guwahati dated 08th November 2024. The estimated amount put to tender is Rs. 159.87 Lakhs.

2. The tender for the above mentioned work amounting to Rs. 159.87 Lakhs was invited by the Chief Engineer PWD (NH), Nagaland on 11.11.2024 and opened on 19.11.2024.

3. The physical form of the bids was to be submitted till 1400 Hrs of 19.11.2024 and till that time, the following bidders had submitted the documents in physical form and the committee proceeded with the online opening of the bid.

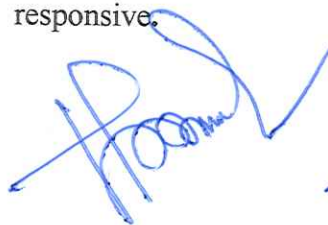
