The Bid were opened on 26.11.2024. The Following 05 Nos (five) bidders participated in this tender.

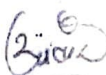

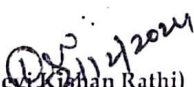
4. Evaluation Committee examined the relevant documents submitted by bidders & evaluated technical bids & the results of technical Proposal are under as per technical evaluation report:-

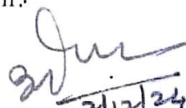

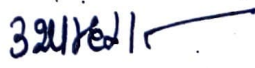
