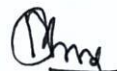

Minutes of Meeting of Evaluation Committee held on 17.02.2025 for Technical Evaluation of bids for the work of Construction of High Level Bridge Across Chulhat Nalla, Bilaspur to Ambikapur Road on NH-130 at Km. 194.840

The work of "Construction of High Level Bridge Across Chulhat Nalla, Bilaspur to Ambikapur Road on NH-130 at Km. 194.840" has been sanctioned by the Ministry for Rs. 4.88 Crore bearing Job No. NH-130-CG-2024-25-05 vide letter No. RW/NH-12014/06/2024/CG-ZoneWest (C No. 242508) Dated 02.12.2024. The Evaluation Committee is constituted as per Ministry's guideline letter No. RW/NH/24035/4/2008-P&M/PIC Vol.II, Dt. 23.02.2018.

2. The bids for "Construction of High-Level Bridge Across Chulhat Nalla, Bilaspur to Ambikapur Road on NH-130 at Km. 194.840" work amounting to Rs. 450.59 Lacs (amount put to tender) were invited by Chief Engineer, NH Zone, Raipur, Chhattisgarh with Online Tender ID No. 2024_MoRTH_835578_1, NIT No. 106/CE/NH/TC/44-41/2024 Raipur Date 19.11.2024 as per Ministry's guidelines as well as through e-tendering.

3. The Member Secretary apprised the Evaluation Committee that bid is based on Standard Bidding Document (SBD). The Member Secretary also apprised the Evaluation Committee that NIT was published in newspapers as per Ministry's guideline dated 30-04-2020 and the bid document was uploaded on web site [<https://eprocure.gov.in/eprocure/app>]

4. It was also apprised to the Committee that bids were available for downloading from ministry's e-tendering portal [<https://eprocure.gov.in/eprocure/app>] from 19.11.2024 to 07.01.2025 (Amended Date) and the last date of online submission/uploading of bid by the bidder was 07.01.2025. The last date of physical submission of tender documents as per requirement of clause 4 of IFB (SBD) and tender notice was 08.01.2025 (17.30 hrs.). The technical bids were opened on 15.01.2025. The following 2 bidders participated in the bid of above subjected work:

- (i) Prakash Chand Rai, Ambikapur (CG)
- (ii) M/s. Shri Sai Associates, Raigarh (CG)

5. The above all bidders have submitted bid as fresh bidder.

6. The physical submissions of above-mentioned bidders were opened by the evaluation committee in front of the authorized representatives of the Bidders, who choose to attend and all required documents as listed as per NIT were checked.

7. The following observations are made by the evaluation committee in accordance to requirements as per SBD for above subjected work: -

- a) All the bidders have physically submitted the documents listed as per Tender Notice.
- b) BID Security in the form of a bank guarantee/ FDR in favour of the SE, PWD, NH Circle, Bilaspur, in the prescribed format shall be valid upto 21.06.2025 (i.e. 45 days from the BID Due Date) as per clause 16.2 of SBD. In case Bid Security BG is not valid upto required date, the bidder shall be requested to extend the validity of Bank Guarantee as per requirement of SBD.
- c) BID Security Bank Guarantee/FDR as submitted by the bidders shall be verified from concerning bank for genuineness.

8. The technical Bids of following 2 bidders who submitted physical documents as per clause 22 of ITB of SBD & Tender Notice and uploaded the bid documents on the website were admitted for online technical opening by the Evaluation Committee: -

- (i) Prakash Chand Rai, Ambikapur (CG)
- (ii) M/s. Shri Sai Associates, Raigarh (CG)

9. In view of above, the Evaluation Committee recommends for proceed with the evaluation of Technical Bids of above listed Bidders as per clause 23 of ITB of SBD.

10. The estimated cost of the project for which bid is invited is less than Rs. 25.00 Cr. hence Joint Venture is not allowed.

11. The Member Secretary presented the comparative statement before the Technical Bid Evaluation Committee.

12. As per the tender called the requirement of **bid capacity** as per clause 4.5.9 of SBD is **Rs. 4.51 Cr.** for individual firm.

13. As per clause 4.5.3 bidders shall have completed atleast **one similar work** of 40% estimated project cost i.e. **Rs. 1.80 Cr. (Rs. One crore eighty lakhs only)** of Highway (Road & or Bridge works) specified in Clause 4.5.3.

14. As per SBD the bidder shall have a minimum **Average Annual Turnover** of **Rs.1.80 Cr. (Rs. One crore eighty lakhs only)** for last five financial years as per clause 4.5.3 of ITB (SBD).

15. As per SBD the bidder shall submit evidence of access to or availability of credit facilities (minimum 10% of estimated cost i.e. Rs. **45.06 Lakhs** certified by the Bankers as per clause 4.2 (i) of ITB (SBD).

16. In accordance to above fixed criteria of SBD, bid capacity, technical & financial capability of all bidders have been evaluated and the criteria of bidder's as per requirement details is attached as '**Annexure-I**' with this document.

17. The following observations are made by the evaluation committee in accordance to requirements as per SBD for above subjected work:-

- (i) The bidder **M/s. Shri Sai Associates, Raigarh (CG)** is found to be **technically non-responsive** as similar work not as per clause 4.5.3 of ITB.

18. The test of responsiveness of the bidder has been checked and only single bidder is found to be **technically responsive** as per clause 23 of SBD -

- (i) **Prakash Chand Rai, Ambikapur (CG)**

19. It was also apprised to the Committee that the above bidder has submitted the Bid Security Bank Guarantee/FDR of amounting to **Rs. 9,01,500/-** in the specified format as per Clause 16 of SBD.

20. It was apprised to the Committee that as per MoRTH circular dated 28.08.2024 for acceptance of single bids for National Highways work, single bid received in open bidding will not be rejected provided the following conditions are satisfied;

- (i) the procurement was satisfactorily advertised and sufficient time was given for submission of bids;



- (II) the qualification criteria were not unduly restrictive; and
(III) prices are reasonable in comparison to market values

21. After detailed deliberation and discussion with confirmation of the conditions mentioned in Para 20 Sr. no. (I) and (II) above, the Evaluation Committee decided opening of the Financial Bid of the above technically responsive single bidder as per the SBD and verification of Bid security Bank guarantee from the respective bank. The Acceptance of bid will be recommended subjected to the condition that the quoted price is reasonable in comparison to market values. The quoted rate shall be examined taking into consideration the comparison with the similar contracts awarded elsewhere within the state.

22. The meeting ended with a vote of thanks to the Chair.

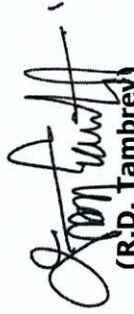
