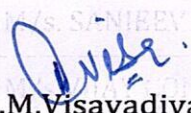
4. The Committee observed that Above all bidders qualify preliminary criteria such as submission of Bid security Declaration, tender fee, And Power of attorney etc.

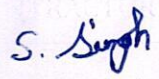

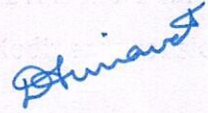

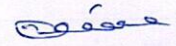
