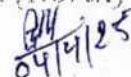

1. The above-mentioned work was sanctioned by Ministry vide letter No File No NH-12014/129/2024-RO Patna (245369)-1864 Dated 18-11-2024 (Job No: NH-727-BR-2024-25 (STMC)-01) amounting to Rs. 2.33 crore. The Civil Cost of the work put to tender was Rs. 2.244 Cr.
2. RFP has been invited online by Executive Engineer, N.H. Division Motihari on 19-11-2024 with bid due date 11-12-2024 which was extended upto 16-12-2024. Technical Bids were opened on 18-12-2024. Following two bidders have participated.
