Ministry of Road Transport & Highways, New Delhi letter in the letter No.RW/BNG/GENL/CRF/121/2020/ dated:12.03.2024 has approved the work "Improvement to road SH-47 to NH-206 via Mathighatta, Suguru, Bochihalli, Kaidala, Karadalusanthe, Kuppalu, Kuppuru road from ch: 17.90 to 20.90 km in Tiptur Taluk" approved under CRIF 2023-24. (Job No: CRIF-KNT-2023-24-141)" for an amount of Rs.120.00 lakhs and the Secretary, PWD, Govt of Karnataka in the Government order ಸಂಖ್ಯೆ:ಬಿಎಚ್‌ಐಡಿ 6 ಸಿ ಆರ್ ಎಫ್ 2024 (ಇ), ಬೆಂಗಳೂರು, ದಿನಾಂಕ: 29-08-2024 has accorded administrative approval.

The tender was called for the said work by the notification No: 01, Date:18-09-2024 through CPP portal <https://eprocure.gov.in> by Executive Engineer, National Highway Division, Tumkur . Amount put to tender is Rs.96.61 Lakhs and the calendar of events were as here under:

The Technical Bids were opened on 19-10-2024, single bidder participated in the tender i.e. **M/s Sree kanteshwara constructions Private Limited** for the tendered work.

The Bidder's documents were downloaded and considered for evaluation. **M/s Sree kanteshwara constructions Private Limited** submitted original E.M.D within the stipulated date and time of opening of tender as specified in the Notice Inviting tender.

The meeting of the Technical Bid Evaluation committee constituted vide letter dt.31.07.2024 comprising the following members was convened on 20.11.2024 in the chambers of the CE, N.H, Bangalore, to evaluate the technical bids received for the above said work.

The technical bid documents substantiating the qualification criteria indicated in the KW-3 was verified. As single bidder participated in Call-I , the committee decided to retender the work and instructions were issued to the Executive Engineer, National Highway Division, Tumkur to retender the work as per the procedures.

The tender – Call II was called for the said work by the Notification No: 03, Date: 28-11-2024 through CPP portal <https://eprocure.gov.in> by Executive Engineer, National Highway Division, Tumkur . Amount put to tender is Rs.96.61 Lakhs and the calendar of events were as here under:

M/s Sree kanteshwara constructions Private Limited have submitted original E.M.D within the stipulated date and time of opening of tender as specified

the Notice Inviting tender. The Bidder's documents were downloaded and considered for evaluation.

The meeting of the Technical Bid Evaluation committee constituted vide letter dt.31.07.2024 comprising the above stated members was convened on 03.01.2025 in the chambers of the CE, N.H, Bangalore, to evaluate the technical bids received for the above said work.

The technical bid documents substantiating the qualification criteria indicated in the KW-3 was verified and the committee has resolved the qualification criteria's of the bidder as under:

TECHNICAL EVALUATION

1. M/s Sree kanteshwara constructions Private Limited.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It has been noticed that bidder has submitted (1) the bid security as per clause 13, 2) Annual turnover report as per Clause 3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bank certificates for credit facilities as per clause 3.3b .

Hence the documents submitted by the bidder satisfies the conditions as per the Bid Document and is Technically Responsive.

COMMITTEE CONCLUSION:-

As the Technical bid submitted by the bidder **M/s Sree kanteshwara constructions Private Limited** are in line with the uploaded bid documents, the committee decided the bidder as Technically Responsive. Further, the below mentioned MoRTH & State Government circular was considered in the consideration of the Single Bidder at Call-II:

1. MORTH Circular EFile No.RW/NH-33044/25/2024-S&R(P&B)(computer No.240989) dated:28.8.2024 single bid received in open bidding will not be rejected provided the following conditions are satisfied :
 - i. the procurement was satisfactorily advertises and sufficient time was given for submission of bids.
 - ii. the qualification criteria were not duly restrictive and
 - iii. prices are reasonable in comparison to market rate

As per the conditions mentioned in para 4 of the circular ,the bidding process satisfies the condition (i)& (ii).

2. And as per the State Government Circular No.FD 576 EXP-12 2018 Dated: 22.05.2018 Single Bid at Call-I was rejected and the work was

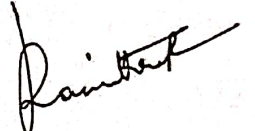
retendered. Furthermore, in the Tender - Call II as well single bidder has participated and is considered technically responsive.

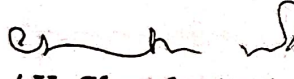

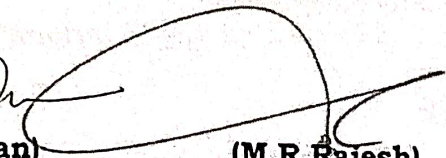

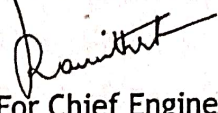
