Sir,

1. This is to notify that the Technical Bids of the bidders who have participated in the bid for the subject mentioned work through e-procurement portal up to 14.00 hrs. of 20.01.2025, were opened online on 21.01.2025 by the undersigned. The following 4(Four) bidders participated in the online bid:

2. It is to inform that out of above 4 (Four) bidders, 1 (One) bidder has not complied the stipulation of the RFP (with and including its Addenda/Corrigendum) and/or fulfilled the qualifying criteria as per RFP (with and including its Addenda/Corrigendum). The deficiencies observed from submitted documents of bidder are mentioned against the name below, thus the Evaluation Committee declared as the bid of the bidder as technically **Non-Responsive**.

(A) I. DEBABRATA DAS

a) Integrity Pact Format pursuant to Appendix-VI, of RFP as per clause 2.11.2 of Section -1 of the RFP has not been submitted by the bidder.

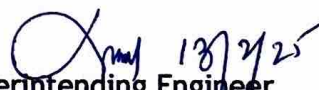
Accordingly, the technical bid of the Bidder is declared as Non Responsive due to non-fulfillment of above criteria.

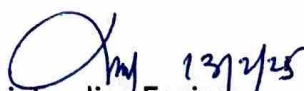
