

Minutes of Meeting of Evaluation Committee for Technical Evaluation held on 31.07.2025 at 11:00 hrs for Consultancy Services for Independent Engineer Services for "4-Laning of Bendordem to Canacona Bypass (Km 570.190 to Km 584.880) and Canacona Bypass to Karnataka border (Km 602.890 to Km 610.300) (Length = 22.10 Km) section of NH-66 on Hybrid Annuity Mode in the State of Goa".

2. As per the recommendation of the Evaluation Committee, the result of technical evaluation was made available on the e-tendering portal on 03.07.2025 giving opportunity to the bidders to respond within 7 days in case they have any objection, as per Clause 10 (vii) of Datasheet of RFP.

3. **Representations:** The bidders have submitted representation towards technical evaluation (copy enclosed at **Annex-II**). The representations are examined and necessary corrections / decisions have been made by the Evaluation Committee which is enclosed at **Annex-I**.

4. **Complaints:** Complaints were received from Shri Anirudh Kumar vide email dated 10.07.2025, Shri Bhavesh Patel email dated 11.07.2025 and Shri. Harendra Mhatre vide email dated 11.07.2025, wherein various discrepancies in the technical evaluation were alleged. The same was forwarded to the concerned bidders who have submitted their response on the complaint. The complaints are examined and necessary corrections / decisions have been made by the Evaluation Committee which is enclosed at **Annex-II**.

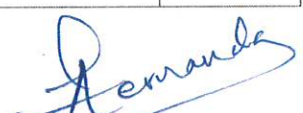
