

Minutes of Meeting of Evaluation Committee for Technical Evaluation held on 15.05.2025 at 16:00 hrs for Consultancy services for Independent Engineer Services for “4-laning of Navelim to Cuncolim Section of NH-66 from Km 554.245 to Km 561.480 on Hybrid Annuity Mode in the State of Goa”.

As per the 1st Minutes of Meeting held on 30.04.2025, following technical result / scores of the bidders were finalized by the Evaluation Committee:

2. As per the recommendation of the Evaluation Committee, the result of technical evaluation was made available on the e-tendering portal on 02.05.2025 giving opportunity to the bidders to respond within 7 days in case they have any objection, as per Clause 10 (vii) of Datasheet of RFP.



3. **Representations:** The bidders have submitted representation towards technical evaluation (copy enclosed at **Annex-II**). The representations are examined and necessary corrections / decisions have been made by the Evaluation Committee which is enclosed at **Annex-I**.

3.1 **Other representations:** A complaint was received from Shri Harendra Mhatre vide email dated 09.05.2025 wherein various discrepancies in the technical evaluation were alleged. The same was forwarded to the concerned bidders who have submitted their response on the complaint.

3.2 The complaint has mentioned that M/s Hexa Private Joint Stock Company in JV with M/s Technocrats Advisory Services Private Limited and in Association with M/s Pentacon Associates has submitted the payment receipt of Rs. 5000/- towards document fee provided by M/s Casta engineers Pvt. Ltd. which is not the part of the Bidder Consortium. Further, it is brought out that the experience certificate of one work completed on 09.02.2018 as per completion certificate (i.e. beyond last 7 years from the bid submission date of 24.02.2025) considered in technical evaluation may not be counted for evaluation.

3.2.1 Evaluation Committee examined the matter and found that tender fee payment receipt is not submitted in the name of bidder which is required as per Clause 9, Section-1 of RFP. Also, after excluding the experience certificate for work completed beyond last 7 years from bid submission date, the Minimum eligibility criteria required as per Clause 15(A) Section-1 of RFP, is not fulfilled by the bidder. Hence, the bidder M/s Hexa Private Joint Stock Company in JV with M/s Technocrats Advisory Services Private Limited and in Association with M/s Pentacon Associates is considered as **technically non-responsive**.

3.3 Evaluation Committee observed that there is no change in the evaluation on account of other issues brought out in the complaint.

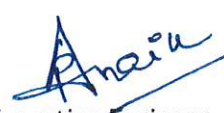
