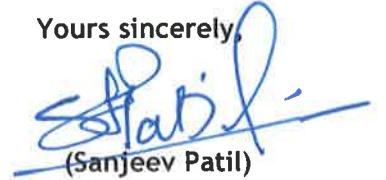
The above Contract Price is inclusive of all taxes, (other than Goods & Service Tax payable in India), duties, fees, levies and other imposition as may be levied under the applicable law and NHLML shall deduct taxes as applicable, out of the eligible payments to be made to the consultants. The amount towards Goods & Service Tax payable in India shall be paid by NHLML separately on reimbursement basis, after submission of proof of depositing the same with the concerned Authorities by the Consultant.

It is requested to furnish within 15 days of issue of this letter of Award (LoA), an unconditional Bank Guarantee from Nationalized Bank as per details mentioned in clause 7 of Section 2 of RFP (Letter of invitation to Consultants) for an amount equivalent to 3% of the Total Contract Value i.e. ₹ 23,68,000/- towards Performance Security. Bank Guarantees shall be as per the relevant format given in the RFP. Performance Security shall be valid for a period of 65 months i.e. upto 2 months beyond the expiry of the Contract Period.

Upon submission of the required Performance Security & after compliance to other conditions stipulated in RFP, you are required to sign the Contract Agreement with NHLML as per clause no. 8 of Section-2 of RFP. Thereafter, the services shall commence immediately as per the Contract Provisions.
