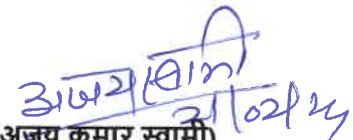
This is with reference to your bids submitted on 07-Feb-2024 for the subject proposal. The results with respect to Technical Evaluation as approved by Competent Authority are as under:

- The bidder M/s Patidar Travels Private Limited has not submitted tender cost of Rs.2,000/- as a mandatory required as per clause 29 of Section 3 of Bid Documents. Further, the bidder has not submitted bid security amounting to Rs.30,000/- as required in clause 5.1(B) of Section-II of Bid Document. The bidder has submitted MSME certification claiming exemption from tender cost and bid security. However, as per RFP & tender details uploaded in etenders portal, no such exemption is permitted for this tender. Accordingly the bidder M/s. Patidar Travels Private Limited has been declared Non-Responsive.
- Remaining three bidders have been found to be responsive. A summary of evaluation of technical bids is as below:-
