4. The Committee has evaluated the bids based on the documents uploaded in the CPPP portal by the bidder and the abstract of evaluation is submitted as under;

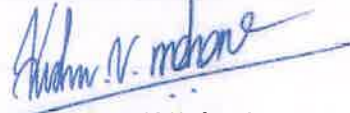
