1. Approval for appointment of a 'Financial Consultant' namely 'M/s. 2. Vide their e-mail dated 05.08.2024 (F/B), the appointed Financial Consultant 'M/s. Raj Har Gopal & Co.' has requested RO-Nagpur to seek clarification over some issues from the 3 bidders, so as to complete the "Technical evaluation" of the received e-bids.
