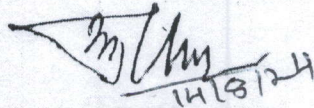

3. It is observed that none of the bidder has submitted / raised any observation / objection on the uploaded "Technical evaluation".

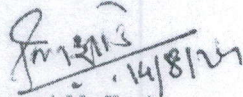
In view of the above, this Committee recommends that financial Bids of all the 'technically responsive Bidders' may be opened.



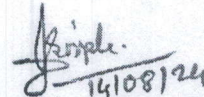

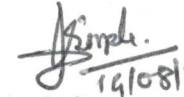
