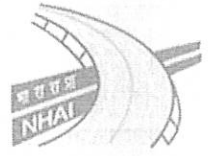

Ltd. (GTAPL). Based on the above, it is inferred that the bidder has incorrectly applied online on e-tender portal as Grant Thornton Bharat LLP (GTBL) instead of Grant Thornton Advisory Pvt. Ltd. (GTAPL). As the Company has separate legal entity and the documents submitted by the bidder who has applied online on e-tender portal are in the name of Grant Thornton Bharat LLP (GTBL) which do not fulfill the eligibility requirements of RFP therefore the bidder is considered as Not Eligible.
