Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 14.09.2024 for the work of "Short Term measures for Rectification of 02 Hotspots/ Accident Spots identified by the Tamil Nadu Special Task Force on Road Safety under the Jurisdiction of PIU-Dindigul at Km 364+200 (Reliance Petrol Bunk), & Km 366+500 (Sengulam Junction) of Karur to Dindigul section of NH-44 in the State of Tamil Nadu on Item Rate Basis" (Tender Ref. No. NHAI/PIU/DGL/2024/HS/).

1. Project Implementation Unit, NHAI, Dindigul invited bids vide Tender ID: 2024_NHAI_198844_2 for the work of "Short Term measures for Rectification of 02 Hotspots/ Accident Spots identified by the Tamil Nadu Special Task Force on Road Safety under the Jurisdiction of PIU-Dindigul at Km 364+200 (Reliance Petrol Bunk), & Km 366+500 (Sengulam Junction) of Karur to Dindigul section of NH-44 in the State of Tamil Nadu on Item Rate Basis" (Tender Ref. No. NHAI/PIU/DGL/2024/HS/) with an estimated cost of Rs.26.816 Lakh (excluding GST).

2. A committee has been constituted with the following members to carry out tender evaluation;

3. As per RFP, the last date of submission of e-bids and date of technical bid opening was scheduled on 17.07.2024 up to 11.00 AM and 18.07.2024 @ 11.00 AM, respectively.

4. Accordingly, the Committee opened the e-bids received through online mode (on 18.07.2024) and decrypted. Totally 03 Nos. of Bids were received through online mode. Subsequently, the details of EMD/Bid Security submitted by the remaining 03 Nos. of bidders were furnished to the Accounts Division. In response, the Accounts Division has confirmed the receipts of the Tender Fee & EMD/Bid Security submitted by the respective bidders.

5. Further, the Committee has admitted & evaluated the 03 Nos. of bids based on available scanned copies. The summary of the detailed technical evaluation is submitted hereunder;

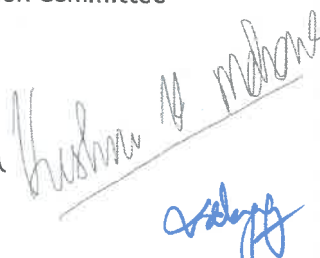
6. As above, the Committee suggests accepting the Bid received from (i) M/s S. Kannan Contractor based on the details furnished by the bidder in compliance with the instructions set forth in the RFP to qualify in the Technical Evaluation.

7. With reference to the bid received from M/s Quad Associates, it is observed that the work experience submitted by the bidder is not as per the RFP. As such, the Tender Evaluation Committee recommends to consider the bid as "non-responsive".

8. Further, with reference to the bid received from **M/s MVR Infrastructures, Dindigul**, it is observed that the bidder has not furnished similar work experience as stated in Clause 4.4A(b) of Section-II ITB RFP. Further, No undertaking, Affidavit & CV of Staff. Hence, the tender evaluation committee recommends considering it as **"Non-responsive"**.

9. During the initial call for bids, only one bid was received, prompting the committee to re-invite bids. In the subsequent call, three bids were received, but only one was technically responsive. Consequently, the case will be evaluated based on this single technically responsive bid. According to the MoRTH Circular dated 28.08.2024, a single bid can be accepted if the conditions outlined in para 4 of the circular are met. The details are as follows:
