PIU, Dindigul, NHAI invited bids vide Tender ID: 2024_NHAI_201634_1 for the work of "Short Term measures for rectification of 11 nos Hotspots/ Accident Spots identified by the Tamil Nadu Special Task Force on Road Safety under the Jurisdiction of PIU-Dindigul at Km 301+300 (Attamparappu Median Opening), Km 303+900 (Kakkavadi Median Opening), Km 312+700 (Malaikovilur PUP), Km 313+840 (Thakarakottai Median Opening), Km 326+940 (Mettupatti Pirivu Median Opening), Km 329+180 (Esanatham Pirivu Median Opening), Km 330+050 (Pallapatti Pirivu Median Opening), Km 334+800 (Z.Alamarathupatti Village Junction), Km 336+900 (Jangalpatti Pirivu Median Opening), Km 338+200 (Aandipatti Regamalai Kanavai), Km 343+680 (Aarthi Hotel) of Karur to Dindigul section of NH-44 in the State of Tamil Nadu on Item Rate Basis." 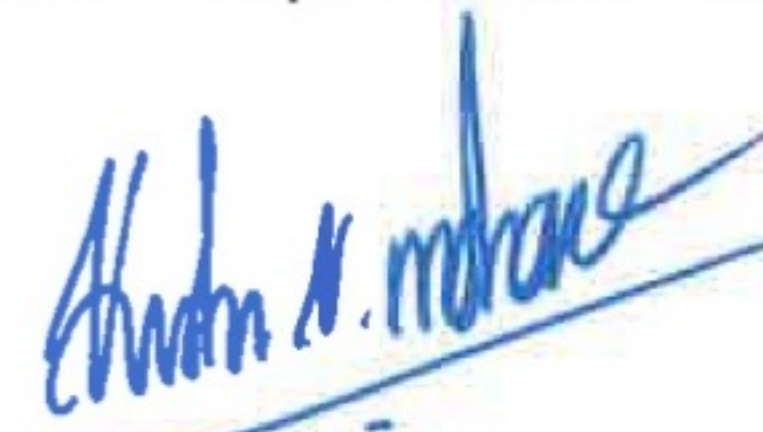
3. A committee has been constituted with the following members to carry out tender evaluation;

4. As per RFP, the last date of submission of e-bids and date of technical bid opening was scheduled on 01.08.2024 up to 11.00 AM and 02.08.2024 @ 11.00 AM, respectively.

5. Accordingly, the Committee opened the e-bids received through online mode (on 02.08.2024) and decrypted. A total of 05 nos. of bids were received online. Subsequently, the details of EMD/Bid Security submitted by the 05 Nos. of bidders were furnished to the Accounts Division. In response, the Accounts Division has confirmed the receipts of the Tender Fee & EMD/Bid Security submitted by the respective bidders.

6. Further, the Committee has admitted & evaluated the 05 Nos. of bids based on available scanned copies. The summary of the detailed technical evaluation is submitted hereunder;

7. As above, the Committee suggests accepting the Bid received from **M/s S. Kannan Contractor & M/s Sharvaa Associates** based on the details furnished by the bidders in compliance with the instructions set forth in the RFP to qualify in the Technical Evaluation.

8. Regarding the bid from **M/s Merukury Electrical Corporation**, it has been noted that the bidder's work experience does not align with the RFP requirements. Additionally, the machinery lease not signed by the lessor, and CVs for only 02 key personnel provided. Therefore, the Tender Evaluation Committee recommends considering the bid as **"non-responsive."**

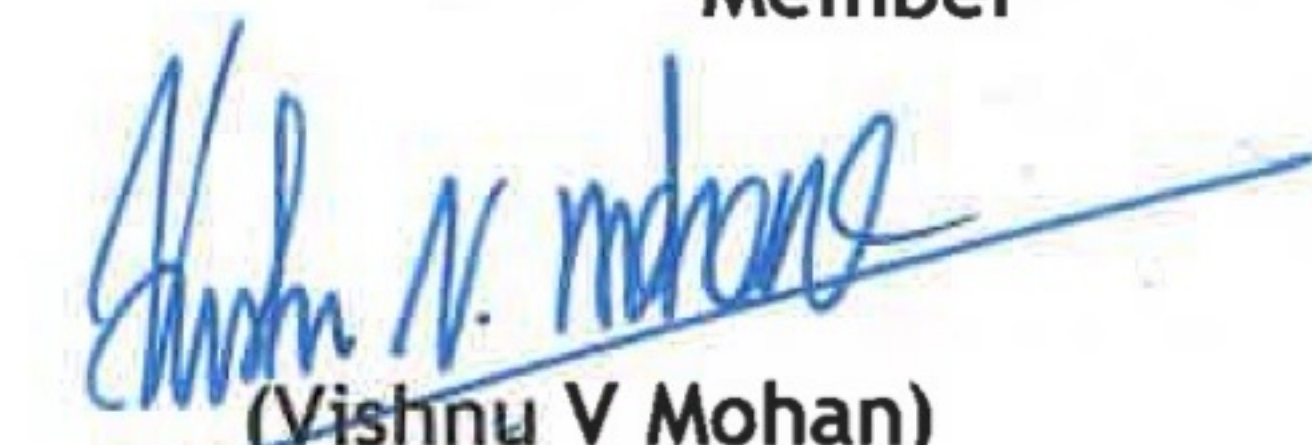
9. Regarding the bid from **M/s Vishnu Infrastructures**, it has been noted that the bidder's work experience does not align with the RFP requirements. Additionally, the machinery/ equipment such as the Water Tanker, Reflectometer & Generator lease/ ownership proof not enclosed, and CVs for only 02 key personnel provided. Therefore, the Tender Evaluation Committee recommends considering the bid as **"non-responsive."**

10. The bid from **M/s KK Builders** has been reviewed, and it has been noted that no CV for key personnel was submitted with the bid. Additionally, the bid capacity does not match, and the sign of the bidder is not on all pages. Therefore, the Tender Evaluation Committee recommends considering the bid as **"non-responsive."**

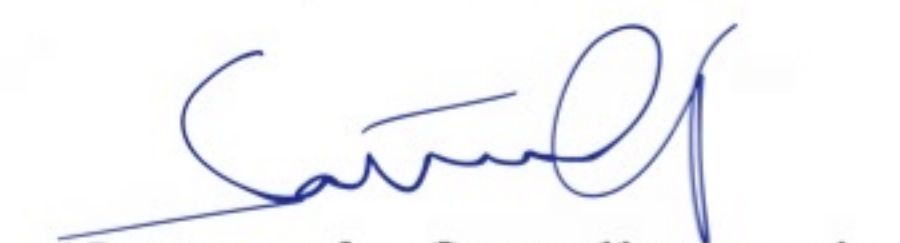
9. The committee further decided to meet at a convenient date to open & evaluate the financial bids of the technically qualified bidders on 03.10.2024.
