Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 16.09.2024 for the work of "Short Term measures for rectification of Accident Spots locations in Madathukulam - Pollachi existing section from Km 26+950 to Km 27+450 (Sakthi Mill Junction), Km 27+225 to Km 27+775 (Vadakkipalayam Pirivu Junction), Km 29+175 to Km 29+675 (CTC Medu to Dorais Theatre), Km 32+075 to Km 35+655 (Chinnampalayam Weighbridge, Pollachi to Udumalai road stretch), & Km 34+450 to Km 34+950 (Pollachi to Udumalai Road, Industrial Junction) of NH-83 (Old NH-209) in the State of Tamil Nadu on Item Rate Basis." 2. PIU, Dindigul, NHAI invited bids vide Tender ID: 2024_NHAI_201660_1 for the work of "Short Term measures for rectification of Accident Spots locations in Madathukulam - Pollachi existing section from Km 26+950 to Km 27+450 (Sakthi Mill Junction), Km 27+225 to Km 27+775 (Vadakkipalayam Pirivu Junction), Km 29+175 to Km 29+675 (CTC Medu to Dorais Theatre), Km 32+075 to Km 35+655 (Chinnampalayam Weighbridge, Pollachi to Udumalai road stretch), & Km 34+450 to Km 34+950 (Pollachi to Udumalai Road, Industrial Junction) of NH-83 (Old NH-209) in the State of Tamil Nadu on Item Rate Basis." (Tender Ref. No. NHAI/PIU/DGL/2024/HS/ TNSTF-RS/05 Nos/) with an estimated cost of Rs.119.30 Lakh (excluding GST).

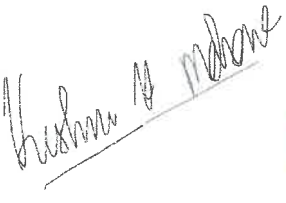
4. As per RFP, the last date of submission of e-bids and date of technical bid opening was scheduled on 01.08.2024 up to 11.00 AM and 02.08.2024 @ 11.00 AM, respectively.

5. Accordingly, the Committee opened the e-bids received through online mode (on 02.08.2024) and decrypted. A total of 03 nos. of bids were received online. Subsequently, the details of EMD/Bid Security submitted by the 03 Nos. of bidders were furnished to the Accounts Division. In response, the Accounts Division has confirmed the receipts of the Tender Fee & EMD/Bid Security submitted by the respective bidders.

6. Further, the Committee has admitted & evaluated the 03 Nos. of bids based on available scanned copies. The summary of the detailed technical evaluation is submitted hereunder;

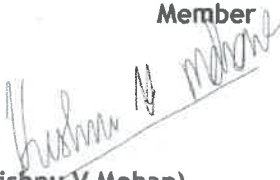
