This is to notify that based on your bid submitted for the subject project, your offer of Bid Price of Rs. 230.00 Crore (Rupees Two Hundred Thirty Crore only), Quoted Bid Project Cost of Rs. 200.35 Crore (Rupees Two Hundred Crore and Thirty-Five Lakh only) and Quoted First Year Fixed O&M Cost of Rs. 5.50 Crore (Rupees Five Crore and Fifty Lakh only) is hereby accepted and you are hereby declared as the "Selected Bidder" as per provision of Clause 3.8.1 of RFP Document. 2. In this regard, you are requested to ensure the following within stipulated time:

- (i) To sign and return the duplicate copy of the LOA in acknowledgement thereof within 7 (Seven) days of receipt of LOA pursuant to Clause 3.8.4 of the RFP.
- (ii) To execute the Concession Agreement within 45 days from issue of LOA pursuant to Clause 1.3 of RFP.
- (iii) To promote and incorporate the Concessionaire as a limited liability company under the Companies Act 2013 and as the entity which shall undertake and perform the obligations and exercise the rights of the selected Bidder under the LOA, including the obligation to enter into the Concession Agreement pursuant to the LOA for executing the Project pursuant to Recital (E) of draft Concession Agreement.
- (iv) The Concessionaire shall, for the performance of its obligations under Concession Agreement, provide to the Authority no later than 30 (thirty) days from the date of the agreement, an irrevocable and unconditional guarantee from a Bank for a sum equivalent to 5 (five) percent of bid project cost quoted by you i.e. Rs. 10,01,75,000 Crore (Rupees Ten Crore One Lakh and Seventy-Five Thousand only) in the form set forth in Schedule-F (the "Performance Security") pursuant to Clause 9.1.1. Of draft Concession Agreement.

3. You are required to comply with the above and all the terms and conditions set forth in the RFP documents. In case of any default on your part, you shall be liable for action as stated in the RFP document.
