Due to following reasons, the bidder found non-responsive:

- UDIN provided by the bidder couldn't be verified for Annex-III & Annex-IV.
- Bidder has not provided the Auditor report and notes to account as per requirement of RFP.
- The projects submitted by the bidder doesn't fulfils the criteria of clause 2.2.2.2(i) and 2.2.2.5 of RFP.
- No such projects have been found which fulfills the criteria similar work criteria of Clause 2.2.2.2 (ii) of RFP. Therefore, bidder found non-responsive.**
