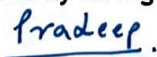

Accordingly, financial bids submitted by M/s RR Tours & Travels and M/s. Ramakrishna cabs were opened and the details of submission are as under:

From the above, the Committee found that, the bid quoted by M/s. R R Tours & Travels for providing, running and maintenance of Mahindra Bolero-B6 vehicle of 2024 Model on monthly hiring basis is Rs.85369.74/-(inclusive of all taxes) per month whereas the bid quoted by M/s. Ramakrishna Cabs is Rs.89899/-. Hence, M/s. RR Tours & Travels has been considered as L-1.

In light of the above, Committee recommends to forward the proposal for approval of Competent Authority for issuance of LOA to M/s. R R Tours & Travels being L-1 bidder at Rs.85369.74/-per month towards providing, running and maintenance of one Mahindra Bolero-B6 vehicle of 2024 Model on monthly hiring basis.
