The Bid Evaluation Committee has evaluated the technical bids as per the provisions of the RFP, and the outcome upon evaluation of technical bids is summarised hereunder:

1. The committee found that the bidder M/s Maruti Abhiyantriki has not submitted Information about the Bidder as per Annex-I of the Bid Documents. Further, the bidder has not submitted a tender cost of Rs. 2,000/- as per clause 1.2.4 of Section 1 of Bid Documents and Demand Draft for bid security amounting to Rs. 10,000/- as required in clause 2.11.3 of Section 2 of Bid Documents. The bidder has not submitted Technical Capacity as per clause 2.2.2.2 of Section 2 of Bid Documents. Accordingly, the committee has declared the bidder M/s. Maruti Abhiyantriki as Non-Responsive.
