Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 25.06.2025 for the work of "Rectification of Accident Spots by Construction of Grade Separated Structure (LVUP) at Km 26+530 (Kollapatti) along with Service Road on BHS, Construction of Service Road of VUP @ Km 25+086 (Kalanjipatti), Junction Improvement & Construction of Service Road at Km 33+200 (Bypass End) and Fixing of Street Lights, Sign Boards from Km 23+100 to Km 33+200 on BHS of Main Carriage Way and Service Road in Oddanchatram Bypass section of NH-83 (NH-209) in the State of Tamil Nadu on Item Rate Basis (3rd Call)" (Tender Ref. No. NHAI/17011/01/100/2024/RO Madurai).

1. Regional Office, NHAI, Madurai invited bids vide Tender ID: 2024_NHAI_207272_3 for the works of "Rectification of Accident Spots by Construction of Grade Separated Structure (LVUP) at Km 26+530 (Kollapatti) along with Service Road on BHS, Construction of Service Road of VUP @ Km 25+086 (Kalanjipatti), Junction Improvement & Construction of Service Road at Km 33+200 (Bypass End) and Fixing of Street Lights, Sign Boards from Km 23+100 to Km 33+200 on BHS of Main Carriage Way and Service Road in Oddanchatram Bypass section of NH-83 (NH-209) in the State of Tamil Nadu on Item Rate Basis (3rd Call)" (Tender Ref. No. NHAI/17011/01/100/2024/RO Madurai) with an estimated cost of Rs.3764.63 Lakh (excluding GST).
2. A committee has been constituted with the following members to carry out tender evaluation;

3. As per Corrigendum-I, last date of submission of e-bids and date of technical bid opening was scheduled on 28.05.2025 upto 11.00 AM and 29.05.2025 @ 11.00 AM, respectively.
4. Accordingly, the Committee opened the e-bids received through online (on 29.05.2025) and decrypted. Totally 03 Nos. of Bids were received through online. Accordingly, the details of EMD/Bid Security submitted by the 03 Nos. of bidders were furnished to Accounts Division. In response, Accounts Division has confirmed the receipts of Tender Fee & EMD/Bid Security submitted by the respective bidders vide Note #... in e-file No.211889.
5. Subsequently, the Committee has admitted & evaluated the 03 Nos. of bids based on available scanned copies. The summary of the detailed technical evaluation is submitted hereunder;

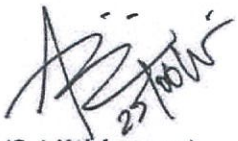

6. As above, the Committee recommends to accept the Bids received (i) M/s M.R Hi-tech Engineers Pvt. Ltd., Ramanathapuram & (ii) M/s R.R. Infraa Construction, Madurai in Technical evaluation based on the details furnished by the bidders in compliance with the instructions set forth in RFP to qualify in the Technical Evaluation.

7. Further, with reference to the bid received from M/s P.K.M Constructions, Madurai, it is observed that, the bidder has not submitted the proof of documentary evidences for some of the requisite machineries either leased/owned/rented as prescribed in Appendix to ITB of RFP i.e. (i) Batch Type Hot Mix Plant (120 Tonne per Hr) & (ii) Horizontal Directional Drilling Machine. Also, for some of the machineries, lease agreement furnished, however, RC Copy/copy of invoice of machineries are not readable viz. (i) Sensor Paver Finisher, (ii) Road Marking Machine (60 sqm/hr), (iii) Tipper (10 ton capacity) & (iv) Smooth Wheeled Tandem Roller (6-8 tonnes). Hence, as per Clause 4.4 B. (d) of Section-II ITB of RFP, the Tender Evaluation Committee recommends to consider the bid as "Non-responsive".

8. Committee further decided to meet at a convenient date to open & evaluate Financial Bids of the technically qualified bidders at the earliest, upon approval of Competent Authority.
