1. Bid notice of captioned subject work was hoisted online on www.etenders.gov.in with submission of Bid latest by 25.09.2024 up to 11:00 Hrs. (Tender ID 2024_NHAI_207408_1 dated 05.09.2024). The schedule for invitation of bids as under:-

3. The bids were opened by the evaluation committee on 26.09.2024. It is found that only three (3) bidders has submitted their bid in online e-portal. The name of the bidders, who have submitted their bids are as under:-

4. The document as uploaded by three firms as well as the technical proposal with respect to bidding document uploaded by the PIU Hanumangarh, have been downloaded and evaluated. The committee evaluated the technical proposal submitted by all three bidders and prepared evaluation sheet at annex-I.
5. As per technical evaluation M/s BL and CK Pvt. Ltd. has not submitted the Power of Attorney as per clause 3.2, A(iii) of RFP & does not fulfill the eligibility criteria, therefore, the bid is non-responsive as evaluation.
6. Further, during evaluation of documents by committee, it has been observed that ownership documents of one vehicle are not traceable in the bid documents of M/s. Radhika Travels Ajmer. In this regard PIU Hanumangarh vide letter number 7052 dated 09.10.2024 has requested to M/s. Radhika Travels, Ajmer for submission of the clarification of the same. M/s. Radhika Travels, Ajmer vide its email dated 10.10.2024 has submitted the documents.
7. Accordingly, the evaluation sheet has been prepared on Annexure-I and following 02 nos of bidders has found technically responsive which details are as under:-
