1. Committee evaluated technical bids and recommended the following;

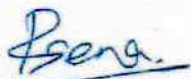

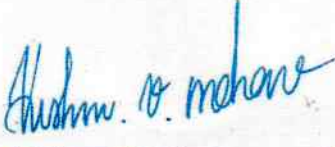
2. Subsequent to approval of Competent Authority, the technical evaluation Minutes was uploaded in Government CPP Portal on 27.01.2025.

3. Consequently, financial bids submitted by technically qualified bidders have been decrypted on 21.02.2025 and amounts quoted by them and the percentage below or above w.r.t. value put to tender (Rs.91,32,821/-) are as under;

Upon noticing the quoted rate of the bidders, M/s Muthuram Enterprises (L-1 Bidder) has quoted abnormally low i.e. 39.49% less than the estimated amount and therefore the Committee recommends to seek detailed justification & Rate Analysis towards the quoted lower price by the bidder to carry out further evaluation, as per Clause 28.3 of Section-II ITB of RFP.
