Minutes of Meeting of Tender Evaluation Committee (Technical Evaluation) dated 27.01.2025 for the work of "Short Term measures for rectification of 12 nos. of Hotspots/ Accident Spots in Madurai-Ramanathapuram section from Km 5/000 to Km 120/484 of NH-85 & 87 (Old NH-49) in the State of Tamil Nadu on an Item Rate Basis" (Tender Ref. No. NHAI/PIU/RMD/HS/TN-STFRS/12 Nos/2024/1).

1. NHAI, Project Implementation Unit, Ramanathapuram invited bids vide Tender ID: 2024_NHAI_207576_2 for the work of "Operation "Short Term measures for rectification of 12 nos. of Hotspots/ Accident Spots in Madurai-Ramanathapuram section from Km 5/000 to Km 120/484 of NH-85 & 87 (Old NH-49) in the State of Tamil Nadu on an Item Rate Basis" (Tender Ref. No. NHAI/PIU/RMD/HS/TN-STFRS/12 Nos/2024/1).with an estimated cost of Rs.91.32 Lakh (excluding GST).
2. A committee has been constituted with the following members to carry out tender evaluation;

3. As per RFP last date of submission of e-bids and date of technical bid opening was scheduled on 11.12.2024 up to 17:30 PM & 12.12.2024 up to 17:30 PM, respectively.
4. Accordingly, the Committee opened the e-bids received through online mode (on 12.12.2024) and decrypted. Totally 05 Nos. of Bids were received through online mode. Subsequently, the details of tender fee deposited by 05.Nos. of bidders were checked and found to be submitted by the respective bidders.
5. Further, the Committee has admitted & evaluated the 05 Nos. of bids based on available scanned copies. The summary of the detailed technical evaluation is submitted hereunder;

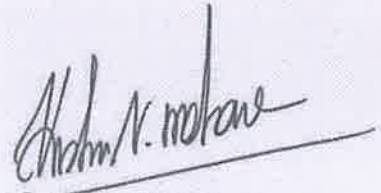

6. As above, the Committee recommended to accept the Bids received from **M/s. Baltej Infra LLP** in Technical evaluation based on the details furnished by the bidder in compliance with the instructions set forth in RFP to qualify in the Technical Evaluation.
7. As above, the Committee recommended to accept the Bids received from **M/s. V Best Engineers** in Technical evaluation based on the details furnished by the bidder in compliance with the instructions set forth in RFP to qualify in the Technical Evaluation.
8. As above, the Committee recommended to accept the Bids received from **M/s. Muthuram Enterprises** in Technical evaluation based on the details furnished by the bidder in compliance with the instructions set forth in RFP to qualify in the Technical Evaluation.
9. With reference to the bid received from **Sh. T Ramar** it is observed that, based on the supporting documents (Experience Certificate) furnished by the bidder, the bidder has not furnished any work completion experience in SH/NH/Expressways. Hence, as per Clause 4.4 A (b) of Section-II ITB of RFP, the tender evaluation committee recommends considering the bid as "Non-responsive".
10. With reference to the bid received from **M/s. G R Engineers and Contractor**, it is observed that, the BG furnished by the bidder has not been confirmed by the CANARA Bank. Hence, as per condition of NIT, the tender evaluation committee recommends considering the bid as "Non-responsive".
11. In this context, Committee has observed that the instant tender is 2nd call and three bids are qualifying for the subject work. Therefore, the tender committee recommends to open Financial Bid on 30.01.2025.
